It is my great pleasure and honor to warmly welcome you to the signing ceremony of the Memorandum of Agreement between the United Nations Economic and Social Commission for Asia and the Pacific and the National Bank of Cambodia.

It is designed to provide a framework that enables all relevant stakeholders to actively participate and reap the benefits of its execution.

On this note, I would like to take this chance to request cooperation and collaboration from various entities such as ministries, regulators, public institutions, financial organizations, private sectors, and development partners to collectively combat climate change.

Before concluding, I would like to extend my gratitude to UNESCAP for your continuous supports to the National Bank of Cambodia, particularly on technical assistance and capacity building to our staff.

I look forward to the successful implementation of our MoA and further deepen our cooperation.
