Introduction

In August 2013, headline consumer price inflation decreased moderately, mainly due to the decrease in the prices of Oil, Recreation and Culture, combined with a lower increase in food price. Cambodian riel (KHR) exchange rate against US dollar appreciated slightly while Credit to private sector accelerated and deposits by residents continued to decline markedly. During the same period, the international trade in goods showed the first time small-surplus in the year.

Consumer Price Index

Consumer price inflation in Phnom Penh (month-on-month) eased to 0.43% in August 2013 from 1.02% in July 2013 reflecting an increase in consumer price index (CPI), from 153.19 in July 2013 to 153.85 in August 2013.

During the period, eight group indexes increased and other four group indexes decreased. The group indexes showing the increases in the month were: Health (1.73%); Restaurants (1.68%); Clothing and Footwear (1.23%); Education (0.86%); Food and Non Alcoholic Beverages (0.71%); Alcoholic Beverages, Tobacco and Narcotics (0.57%); Communication (0.25%); and Housing, Water, Electricity, Gas and Other Fuels (0.21%).

The group indexes decreasing during the month were: Recreation and Culture (2.06%); Transport (1.58%); Miscellaneous Goods and Services (0.31%); and Furnishings and Household Maintenance (0.13%).

The increase in Food and Non Alcoholic Beverages resulted from the increases of 0.7% in the index for food sub-group and 0.4% in the index for Non-Alcoholic Beverages sub-group. The increase in food sub-group index mainly resulted from the increases in the prices of Fish and Seafood (2.3%), Beef (1.3%), Pork (1.2%), Duck (0.8%), Chicken (0.7%), Rice (0.4%), and Milk, Cheese and Eggs (0.4%). The increase in Non-Alcoholic Beverages sub-group was due to the increases in the prices of Mineral waters, Soft drinks, Fruits and Vegetable juices (0.6%) and Coffee, Tea and Cocoa (0.1%). The decrease in Transport group index was mainly due to the decreases in the prices of Spare parts and accessories for personal transport equipment (4.5%), Gasoline (3.9%), Diesel (1.9%), and Motor oil (1.3%).

Based on year-on-year percentage change of the CPI for all items, headline inflation moderated to 3.3% in August 2013 from 3.96% in July 2013, mainly due to the decreases in the prices of oil and housing and a lower increase in the price of food.

Exchange Rate

The value of KHR against the US dollar appreciated slightly in August 2013. The market buying rate decreased from KHR 4,094 per US dollar at the end of July 2013 to KHR 4,092 per US dollar at the end of August 2013, an appreciation of 0.04% compared to the depreciation of 0.22% in July 2013.

During the period, daily market buying rate varied between KHR 4,090 and KHR 4,096 per US dollar. As shown in Chart 7, the value of KHR was fixed with a rate KHR 4,091 per US for the first four days of the month followed by a consecutive depreciation from KHR 4,094 per US dollar on the fifth to KHR 4,096 per US dollar on the ninth. After that, the KHR showed an appreciation trends by treated on KHR 4,094 per US dollar from the tenth to the sixteenth, KHR 4,093 per US dollar from the seventeenth to the nineteenth, and KHR 4,090 per US dollar from the twentieth to the twenty fifth. Later on, the KHR depreciated to treat on KHR 4,092 per US dollar from the twenty sixth to the end of the month.

Money Supply

In August 2013, broad money (M2) continued to decrease markedly which decreased in three months consecutively, down by KHR 1,177.3 billion (3.9%) after decreasing KHR 1,342.9 billion (4.2%) in July 2013, from KHR 30,316.1 billion in July 2013 to KHR 29,138.9 billion in August 2013. The decrease resulted from the decreases of KHR 1,207.6 billion (4.9%) in residents' foreign currency deposits and KHR 105.0 billion (2.4%) in currency outside banks, while demand deposits and time and saving deposits increased by KHR 99.3 billion (27.1%), and KHR 36 billion (4.5%), respectively.

Net Domestic Assets of the Banking Sector

Net domestic assets of the banking sector decreased slightly in August 2013 after increasing in the previous four months consecutively, down by KHR 32 billion (0.3%) after increasing KHR 455.3 billion (4.6%) in July 2013. This was due to a decrease of KHR 61.4 billion (0.5%) in other items net while domestic credit increased by KHR 29.4 billion (0.1%). The decrease in other items net was mirrored by an increase of KHR 354.7 billion (3.0%) in capital and reserves and partly offset by an increase of KHR 287.7 billion (268.8%) in other items and a decrease of KHR 5.6 billion (0.7%) in restricted deposits.

The increase in domestic credit was reflected by the increases of KHR 22.6 billion (0.1%) in credit to private sector and KHR 7.9 billion (0.3%) in net claims on government while credit to state enterprises decreased by KHR 1.2 billion (9.4%). The increase in net claims on government was entirely due to a decrease of KHR 7.9 billion (0.3%) in government deposits while claims on government remained stable.

Net Foreign Assets of the Banking Sector

Net foreign assets of the banking sector in August 2013 continued to decrease modestly, down by KHR 1,145.2 billion (5.7%) after decreasing KHR 1,798.3 billion (8.3%) in July 2013. This was due to a decrease of KHR 862.9 billion (3.3%) in total foreign assets contributed with an increase of KHR 282.2 billion (4.6%) in total foreign liabilities. The decrease in total foreign assets resulted from a decrease of KHR 654.7 billion (7.7%) in foreign assets of commercial banks and KHR 208.3 billion (1.2%) in foreign assets of the

National Bank of Cambodia. The increase in total foreign liabilities resulted from the increases of KHR 281.7 billion (5.0%) in foreign liabilities of commercial banks and KHR 0.6 billion (0.1%) in foreign liabilities of the National Bank of Cambodia.

Deposit Money Banks' Operations

As shown in Table 12, total assets of commercial banks and specialized banks continued to decline at a slower pace in August 2013. Total assets of these banks decreased from KHR 46,874 billion in July 2013 to KHR 45,984.8 billion in August 2013, down by KHR 889.2 billion (1.9%) compared to the decrease of KHR 1,224.3 billion (2.5%) in July 2013. This decrease was due to the decreases of KHR 654.7 billion (7.7%) in foreign assets, KHR 205.1 billion (2.5%) in cash and deposits with the central bank and KHR 50.7 billion (1.2%) in fixed and other domestic assets while loans and advances to residents increased by KHR 21.4 billion (0.1%). The increase in loans and advances to residents was due to an increase of KHR 22.6 billion (0.1%) in credit to private sector while credit to nonfinancial public enterprises declined by KHR 1.2 billion (9.4%).

The total liabilities of all banks in the month showed decreasing which was reflected by the decreases of KHR 1,105.4 billion (4.3%) in deposits by residents and KHR 330.3 billion (5.4%) in domestic liabilities while foreign liabilities and capital and reserves increased by KHR 281.7 billion (5.0%) and KHR 264.9 billion (2.9%), respectively. The decrease in deposits by residents resulted from a decrease of KHR 1,207.6 billion (4.9%) in foreign currency deposits while demand deposits and time and saving deposits increased by KHR 66.2 billion (22.7%) and KHR 36 billion (4.5%), respectively.

Interest Rates on Loans and Deposits

In August 2013, the interest rate movement with a maturity of 12-month on loans and deposits showed that the weighted average deposit rate in KHR decreased by 0.04% from 5.98% in July 2013 to 5.94% in August 2013 while the same rate of deposit in US Dollar remained stable by keeping the same rate of 4.39% as in July 2013.

During the period, the weighted average lending rate in KHR was fixed with a rate 11.93% in August 2013 while the same rate for lending in US dollar decreased by 0.05% from 11.42% in July 2013 to 11.37% in August 2013.

The banks' interest rate spread between loan and deposit rates in KHR widened from 5.95% in July 2013 to 5.99% in August 2013, and the spread in US dollar narrowed from 7.03% in July 2013 to 6.98% in August 2013.

Foreign Tourist Arrivals

The number of foreign passenger arrivals in Cambodia continued to increase at a slower pace in August 2013. The total number of passenger arrivals increased from 338,761 persons in July 2013 to 342,064 persons in August 2013, up by 3,303 persons (1%) following the increase of 37,349 persons (12.4%) in a month earlier. The increase in the number of passenger arrivals was apportioned by modes of arrival as follows: Passenger arrivals by air at Siem Reap International Airport, up by 10,469 persons (13.7%) and Passenger arrivals by water, up by 967 persons (24.9%) while Passenger arrivals by land, down by 6,920 persons (3.6%) and Passenger arrivals by air at Phnom Penh International Airport, down by 1,213 persons (1.8%). The main purpose of the passenger arrivals in Cambodia was for vacation accounting for more than 94% of the total. Most of the foreign passengers were from Vietnam (22.4%), Lao PDR (12%), China P.R.C. (11.1%) and South Korea (8.2%) followed by Japan (6.8%), Thailand (5.3%), France (3.7%), Malaysia (3.2%), the United States of America (3%), and the Philippines (3%).

International Trade in Goods

In August 2013, the international trade in goods showed the first time small-surplus of 1.1% in the year following the deficit of KHR 337.7 billion (13.2%) in July 2013.

Total exports (fob) increased significantly by KHR 519.3 billion (23.3%) in the month after decreasing KHR 50.5 billion (2.2%) in July 2013, from KHR 2,229 billion in July 2013 to KHR 2,748.2 billion in August 2013. The increase was mainly due to the increases in the exports of Garment (KHR 494.4 billion or 26.9%), Rubber (KHR 12.9 billion or 20.6%), and Textile (KHR 1.2 billion or 14.7%) while imports of Swan Timber and Footwear declined by KHR 9.4 billion (37%) and KHR 2.5 billion (2.1%), respectively.

Total imports (fob) increased moderately in August 2013, up by KHR 150.9 billion (5.9%) after decreasing KHR 397.9 billion (13.4%) in July2013, mainly due to the increases in imports of Petroleum products (KHR 20.5 billion or 6.8%), Cigarettes (KHR 12.9 billion or 19%), Cloths (KHR 6.5 billion or 20.9%), Cement (KHR 2.4 billion or 10.8%), Clothing (KHR 2.4 billion or 17.2%), Construction Material (KHR 2.3 billion or 10.5%), and Sugar (KHR 1.6 billion or 39.8%) while imports of Vehicles, Motor Bikes, and Steel declined by KHR 25.3 billion (17.8%), KHR 9.7 billion (22.3%), and KHR 2.7 billion (12.7%), respectively. In the meantime, imports of other commodities changed slightly.





Chart 1: Consumer Price Index





Table 3: Gross Domestic Product (GDP)












Chart 9: Monetary Survey




Chart 10: Components of Money Supply


