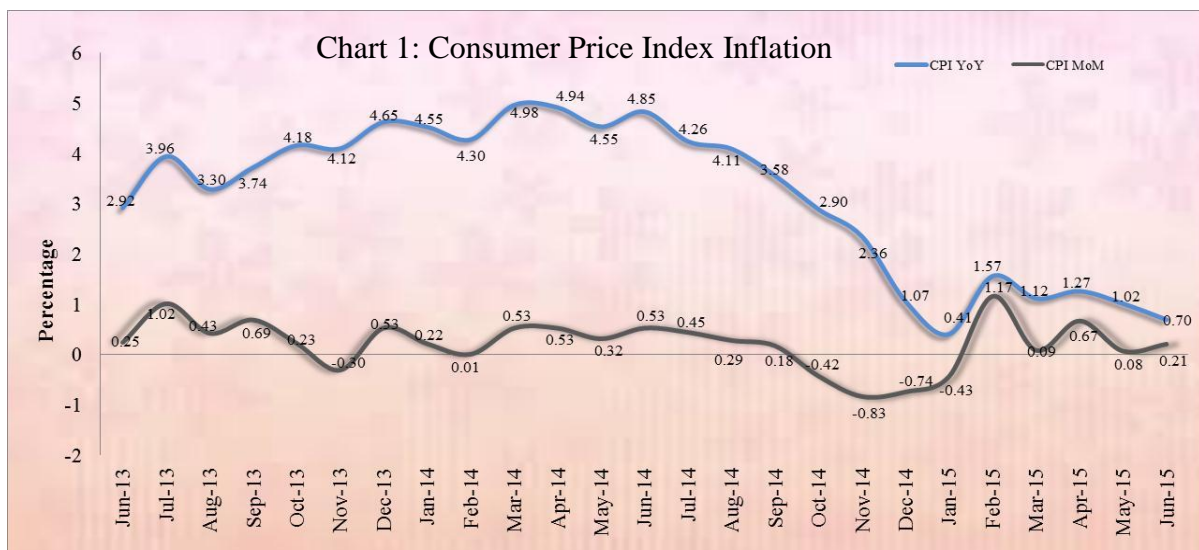

Introduction

Headline consumer price inflation in June 2015 increased slightly after decreasing in the preceding month. During this period, Cambodian Riel (KHR) continued to depreciate against US dollar and banking transaction reflected by continued in lending and deposits. At the same time, the international trade in goods showed a decrease in deficit.

Consumer Price Index

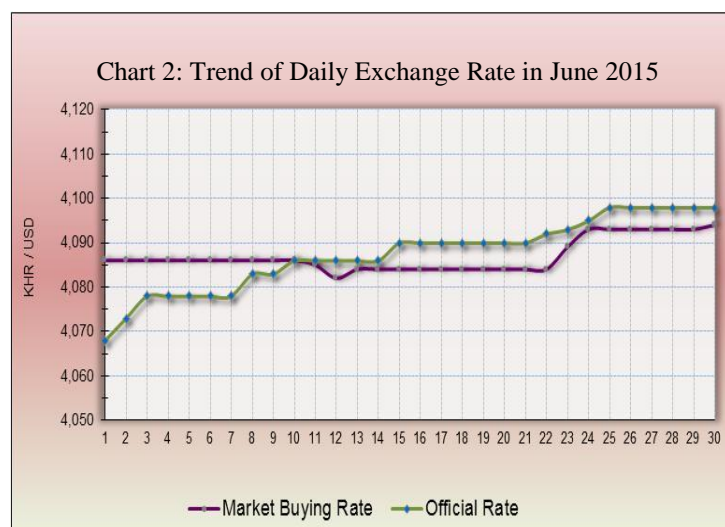
The consumer price inflation in Phnom Penh (month-on-month) accelerated to 0.21% in June from 0.08% in May 2015. In which, six out of twelve group indexes increased while five group indexes decreased and the other one remained stable.



During the same period, the year-on-year percentage change of the CPI for all items decreased to 0.70% in June from 1.02% in May 2015, mainly due to a decrease in oil price and a lower hike in food price.

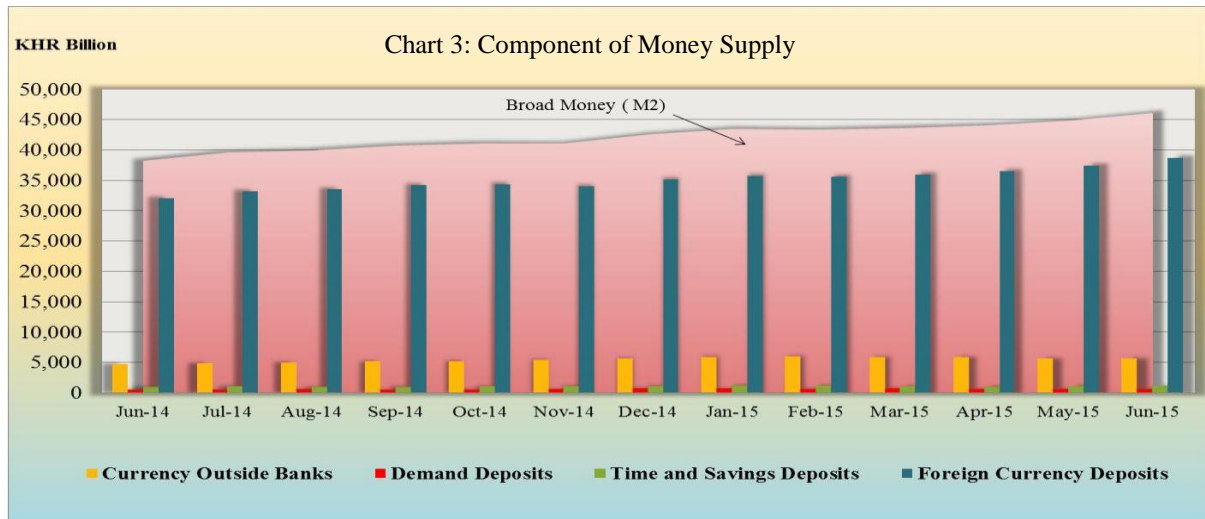
Exchange Rate

The exchange rate (market buying rate) was KHR 4,094 per US dollar in June 2015, depreciated by 0.2%, compared to the previous month. This was due to the decrease in demand for KHR in the rainy season.



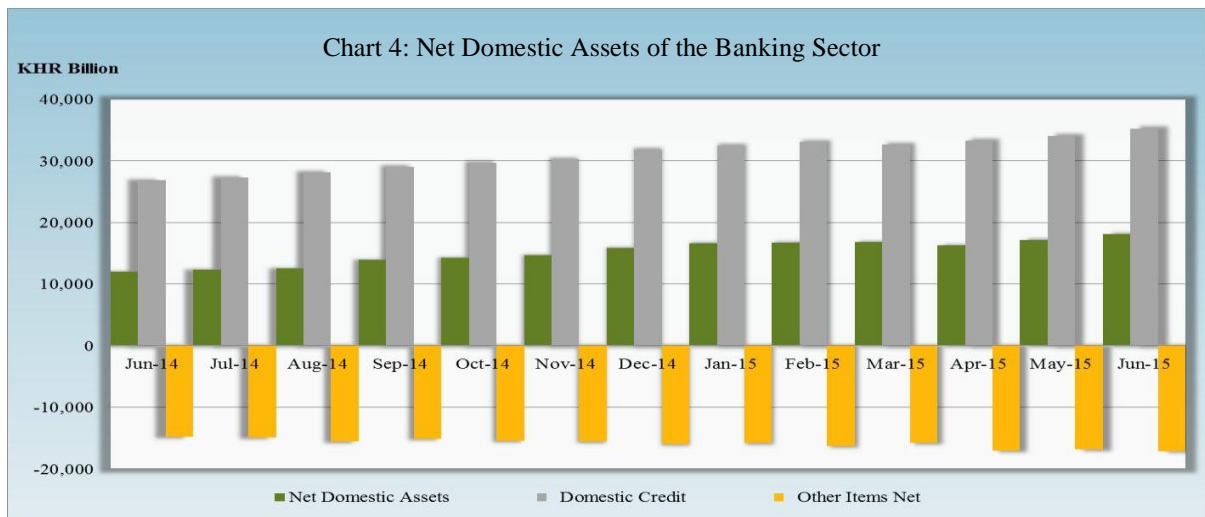
Money Supply

Broad money (M2) continued to increase moderately to KHR 46,153.6 billion in June 2015, up 2.9% compared to May 2015. The components of M2 including time and saving deposits, and resident's foreign currency deposits, increased by 4.6% and 3.4%, respectively while demand deposits and currency outside banks decreased by 0.7% and 0.02%, respectively.



Net Domestic Assets of the Banking Sector

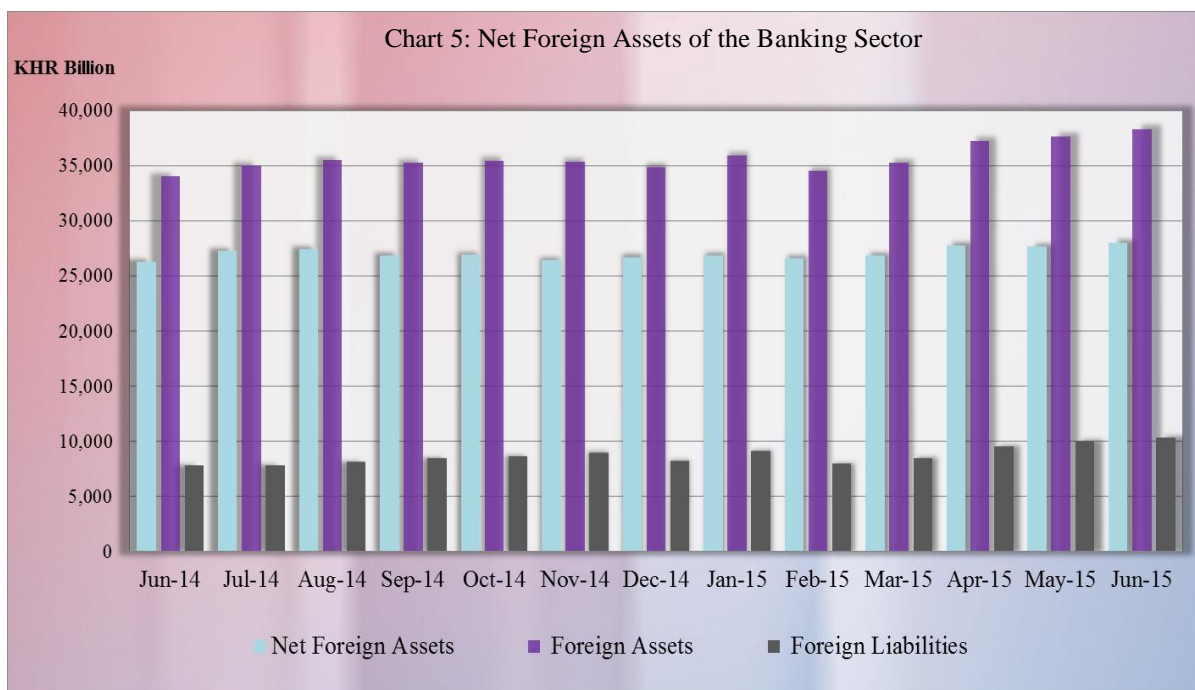
Net domestic assets of the banking sector in June 2015 continued to increase to KHR 18,178.3 billion, up 5.5% from the previous month, due to an increase of 3.6% in domestic credit while other items net decreased by 1.6%.



The increase in domestic credit was reflected by an increase of 3.4% in credit to private sectors while net claims on government decreased by 2.1%.

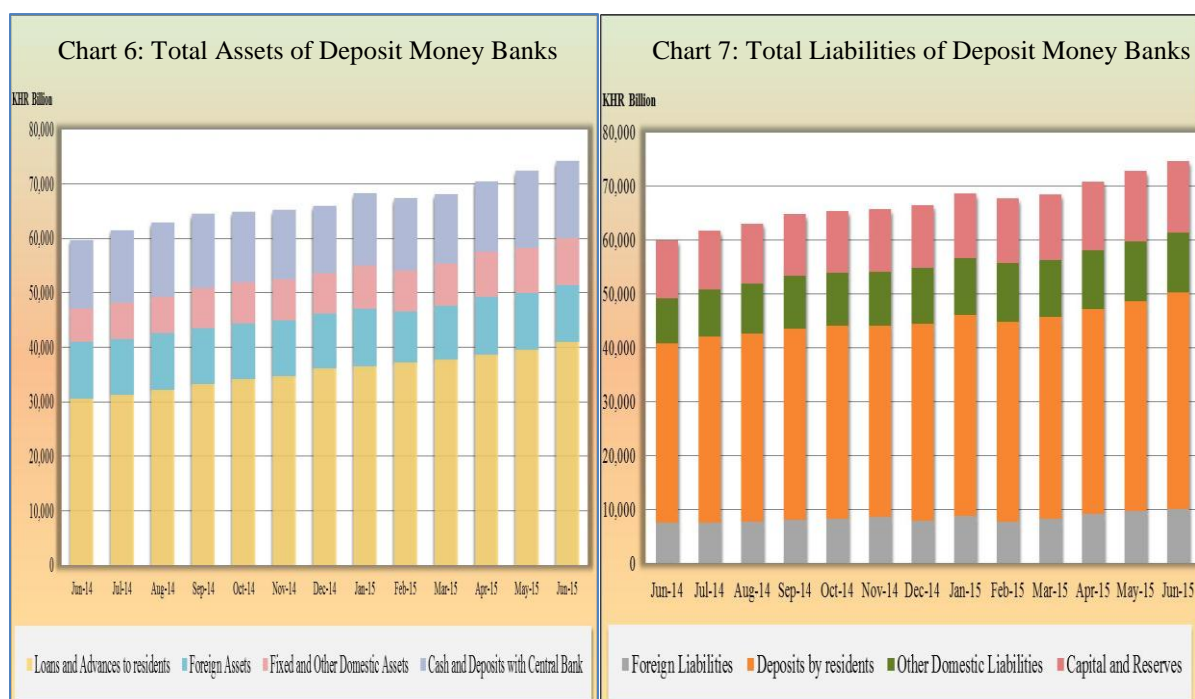
Net Foreign Assets of the Banking Sector

Net foreign assets of the banking sector increased to KHR 27,975.3 billion in June 2015, up by 1.3% from May 2015, mainly due to an increase of 1.5% in total foreign assets.



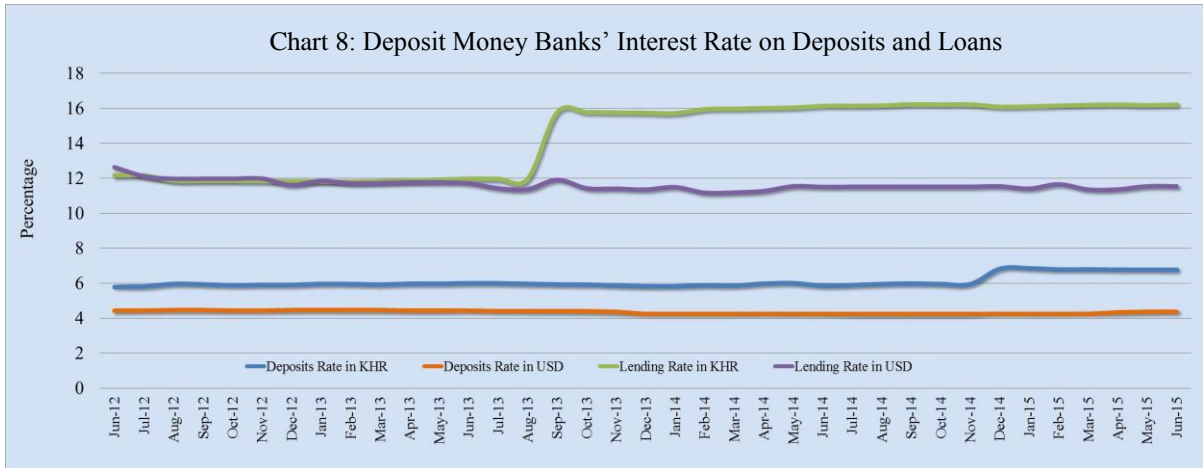
Deposit Money Banks' Operations

Total assets of commercial banks and specialized banks were KHR 74,507.3 billion, up by 2.6% in June 2015 from the previous month.



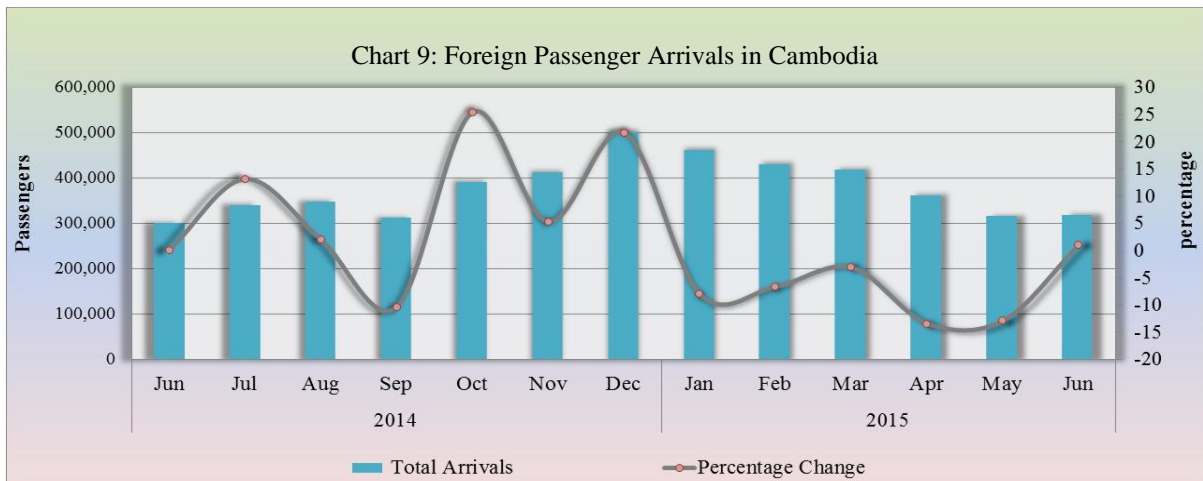
Interest Rates on Loans and Deposits

In June 2015, the interest rate movement of a 12-month maturity loans and deposits showed that the weighted average deposit rate in KHR decreased slightly by 0.003% while deposit in US Dollar increased by 0.01%. At the same time, the weighted average lending rate in KHR increased by 0.04% while lending rate in US dollar decreased by 0.01%.

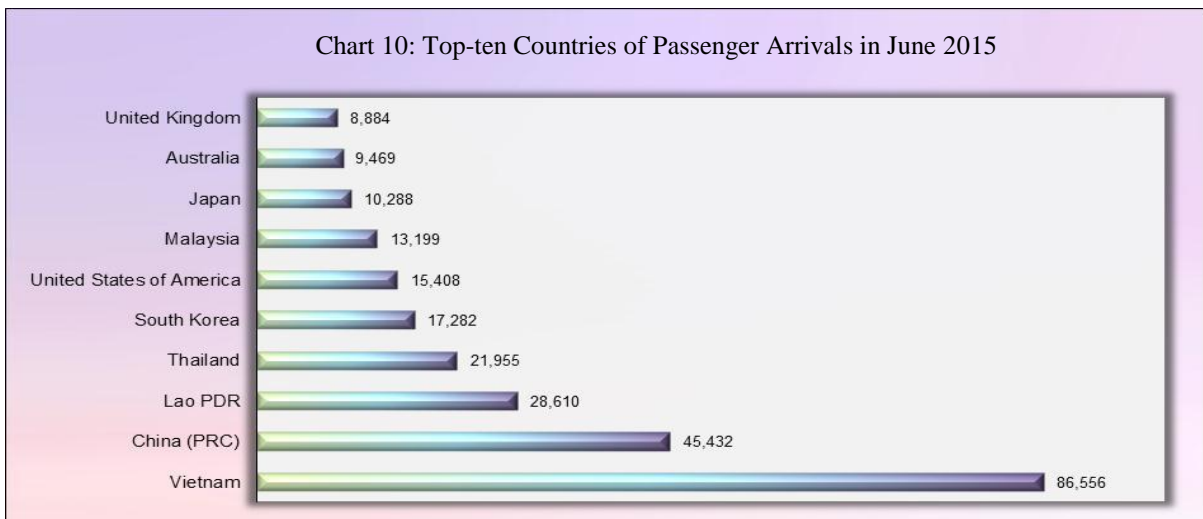


Foreign Tourist Arrivals

In June 2015, the total number of passenger arrivals was 318,267 passengers; up by 1.1% following the decrease of 12.8% last month. The main purpose of the passenger arrivals in Cambodia was for vacation, accounting for more than 88% of the total.



Most of the foreign passenger arrivals were from Vietnam, China P.R.C., Lao PDR, Thailand, South Korea, United States of America, Malaysia, Japan, Australia, and United Kingdom.



International Trade in Goods

International trade in goods showed a deficit of KHR 746.4 billion (20.1%) in June, from the deficit of KHR 1,315.7 billion (35.2%) in May 2015.



The major components of total exports were Garment, Footwear, Rubber, Sawn Timber, Textile, and Fish Products; whereas the major components of total imports were Petroleum, Vehicles, Gold, Motor Bikes, Steel, Cigarettes, Construction Materials, Cement, Clothing, Beer, and Cloths.

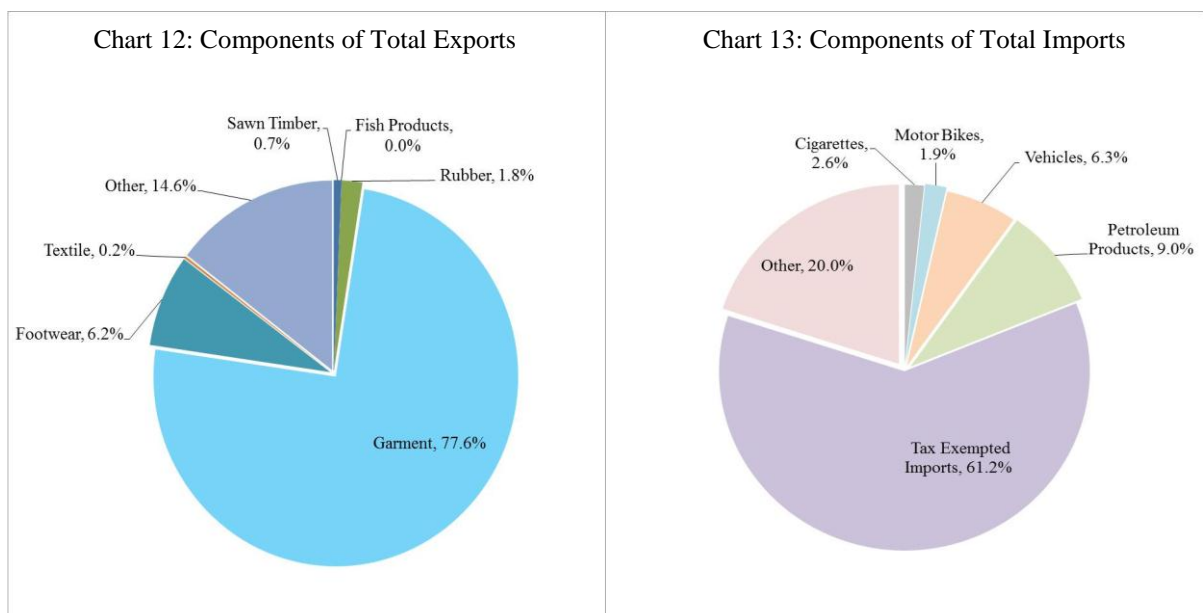

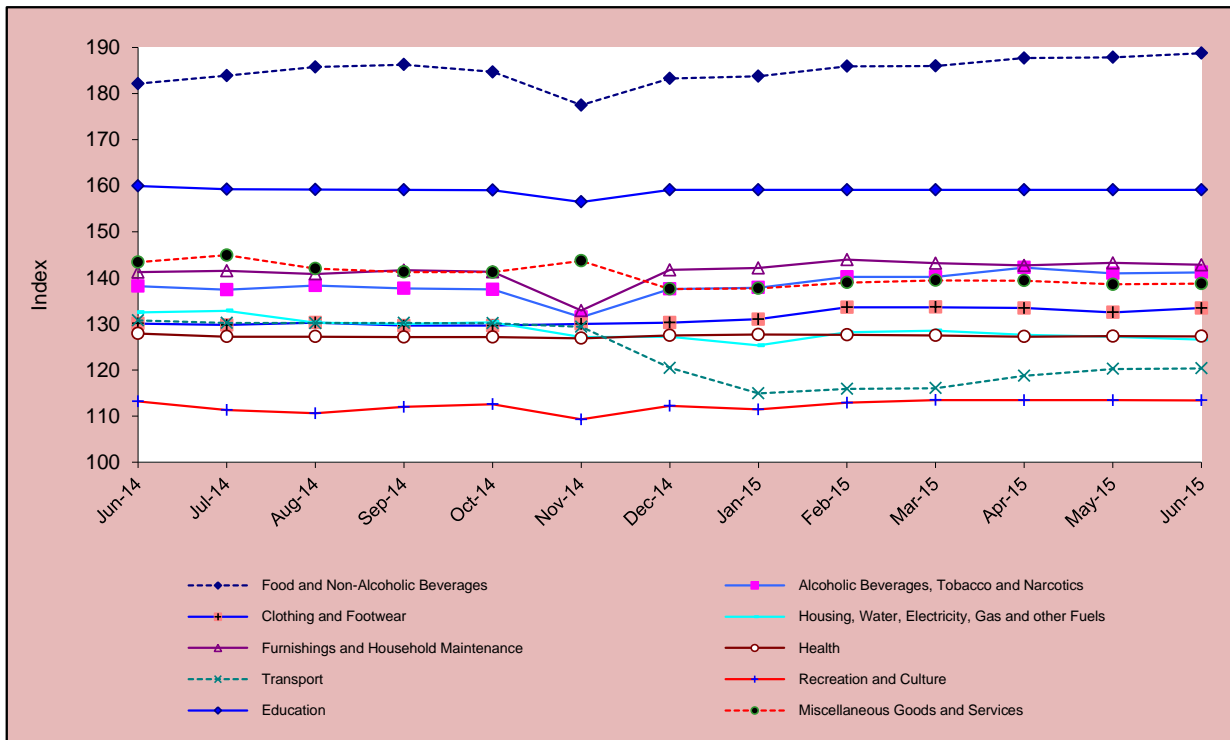

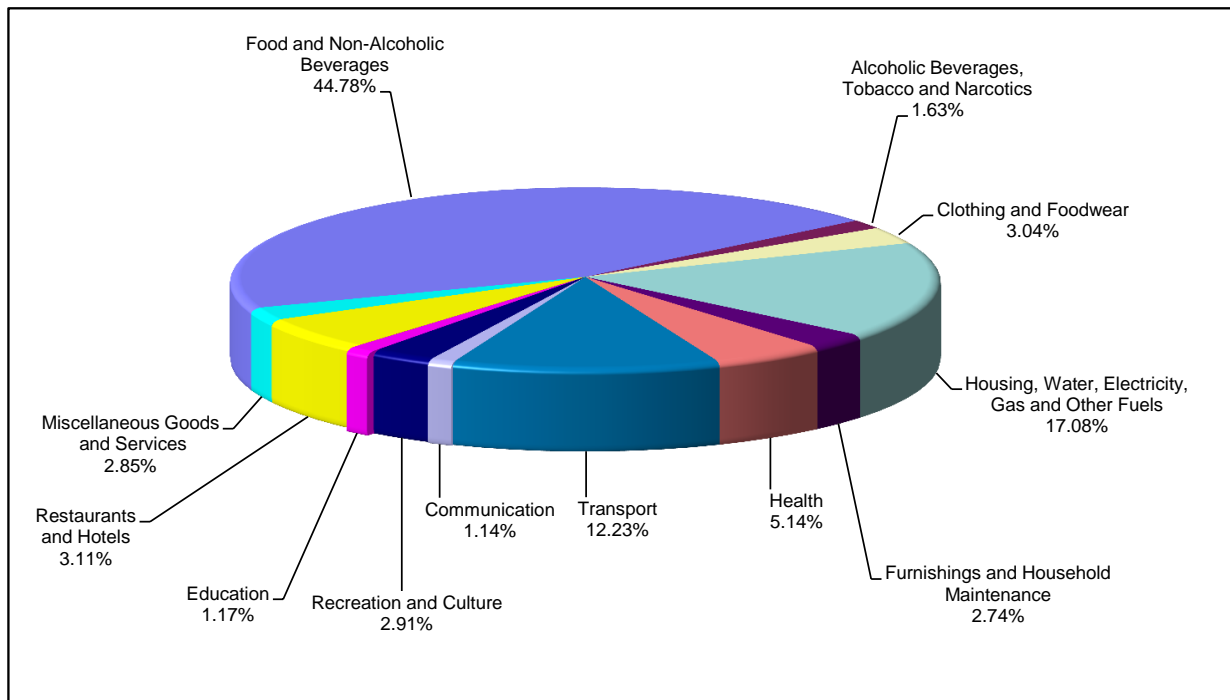

(At Constant 2000 Prices)

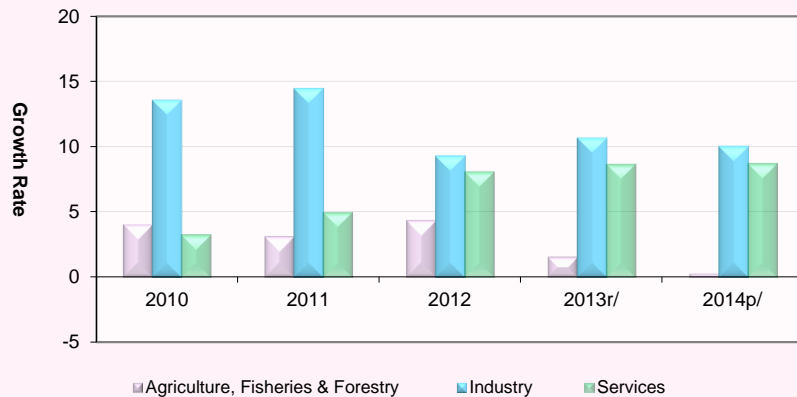
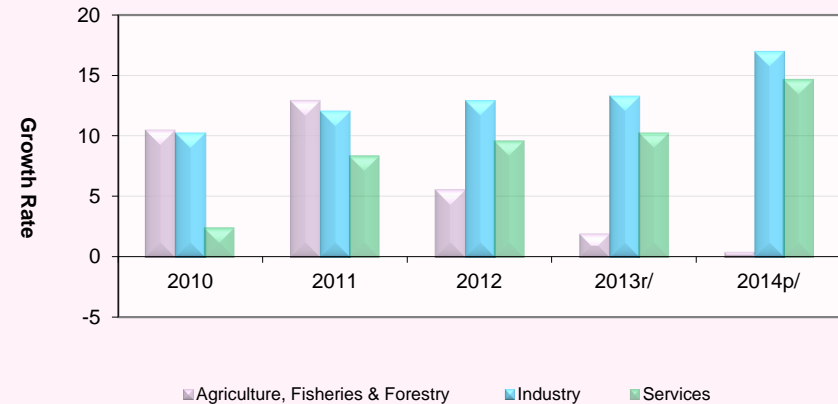


Chart 4: GDP by Economic Activity

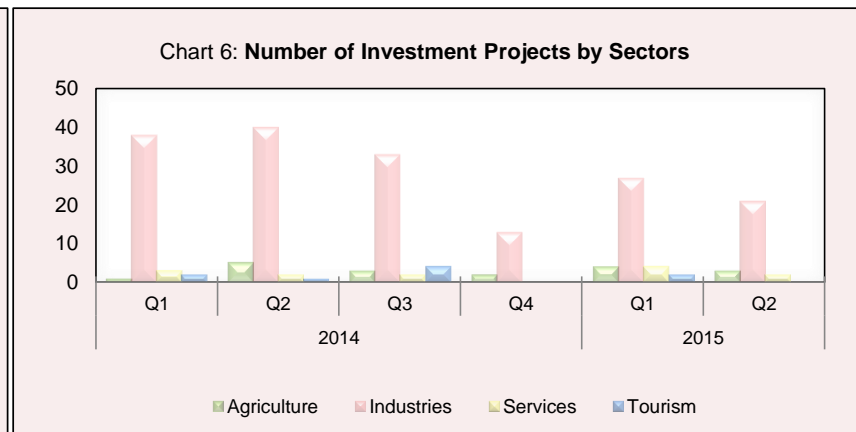
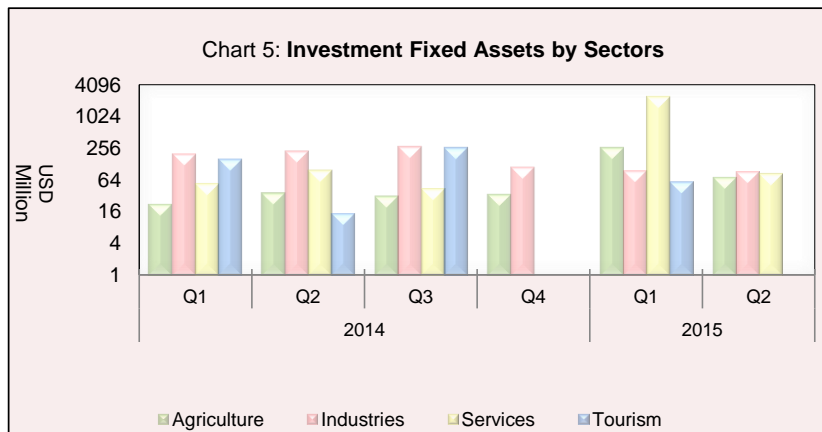

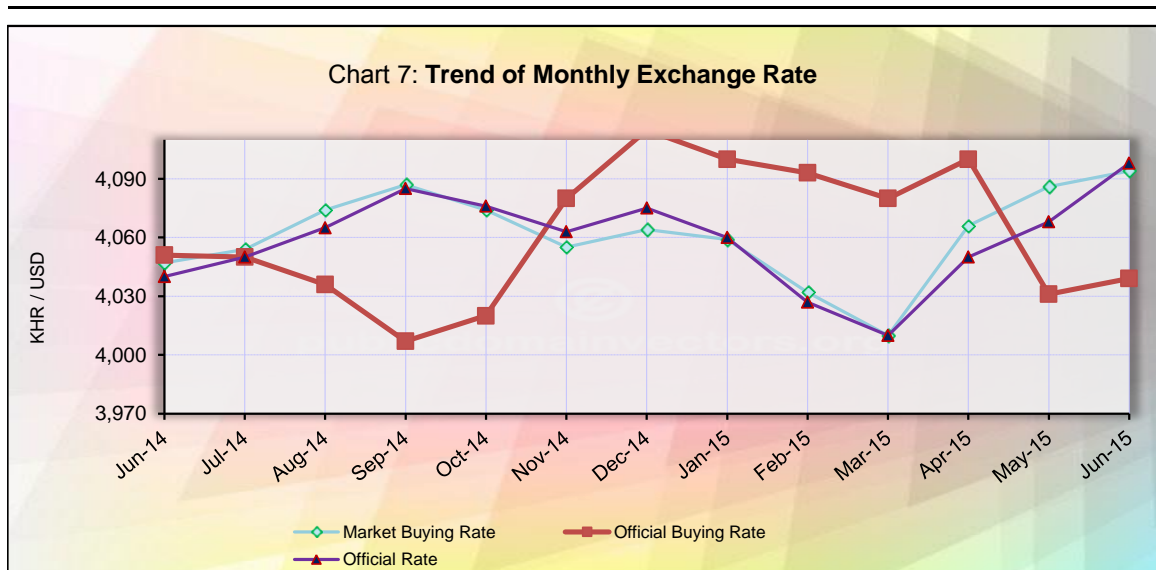

Chart 8: Monetary Survey

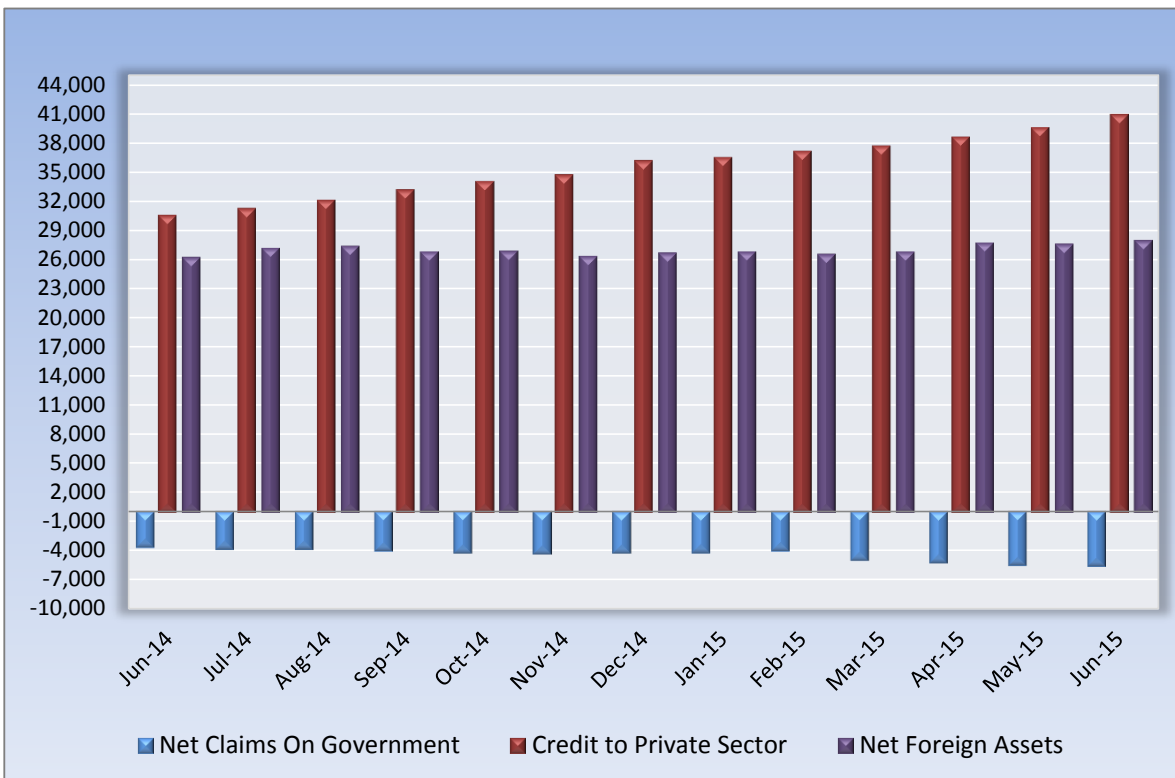


Chart 9: Components of Money Supply

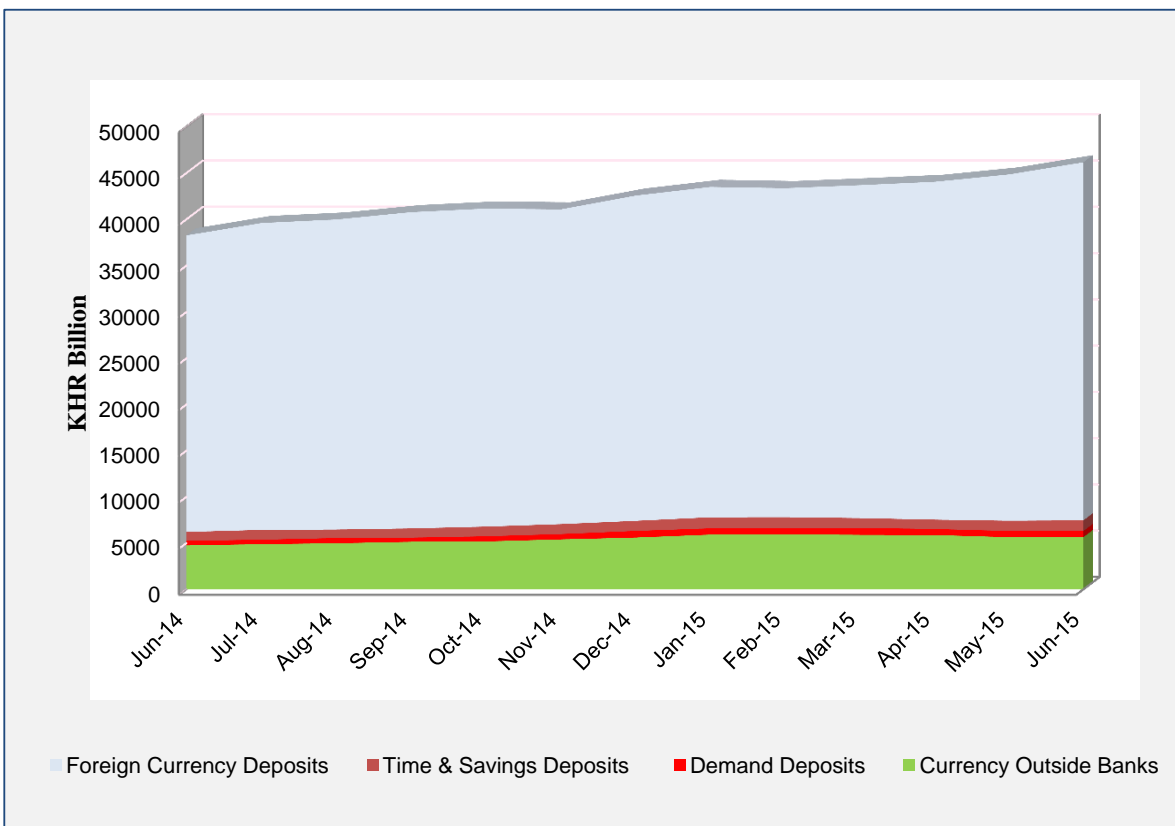

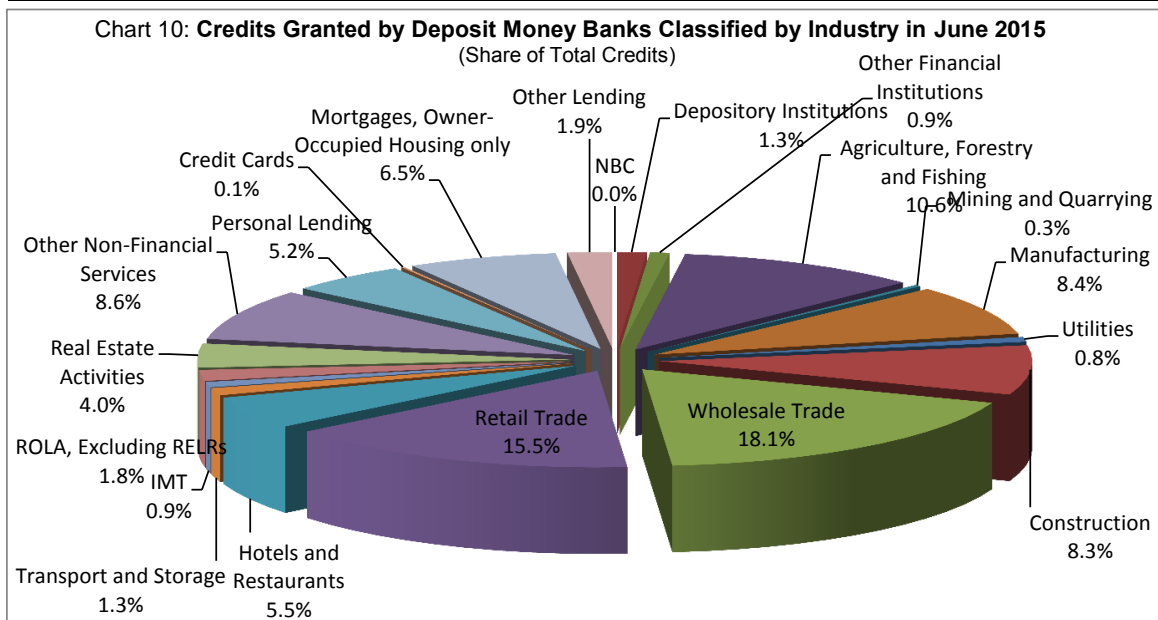

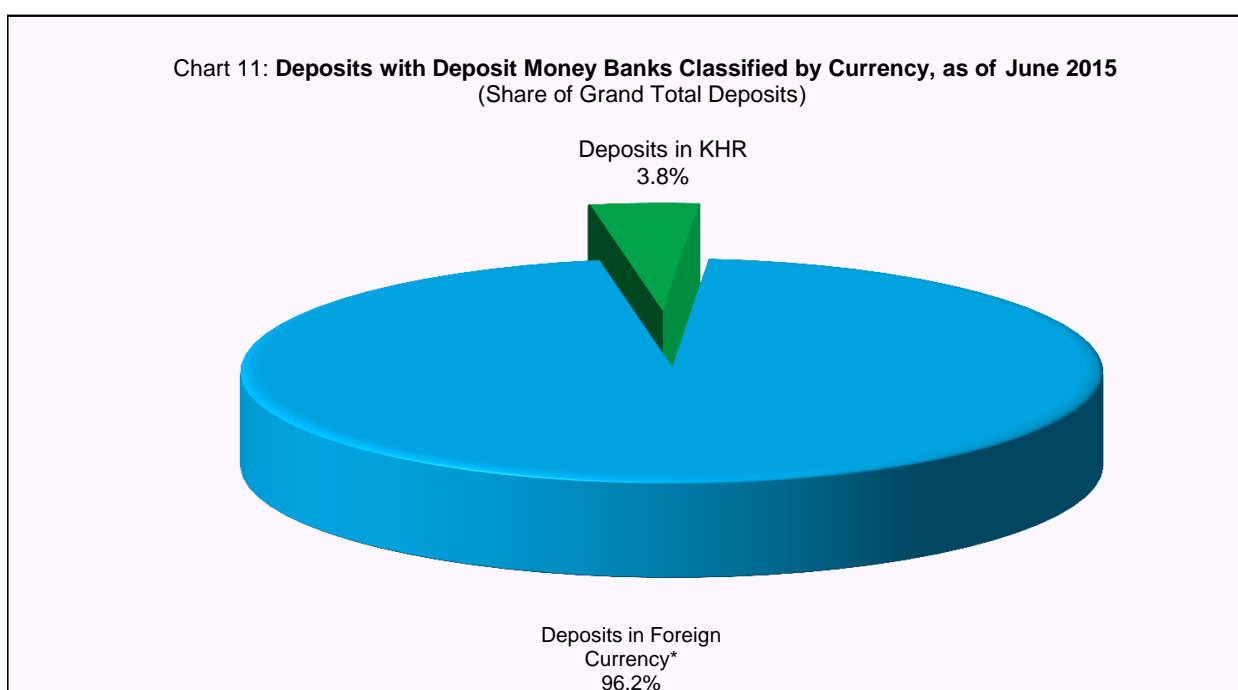

(Share of Total KHR Deposits)

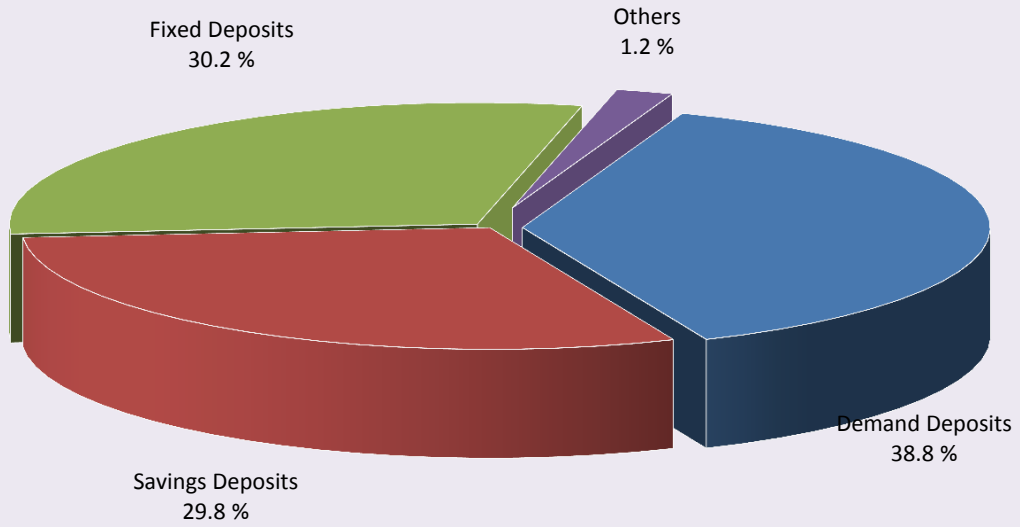
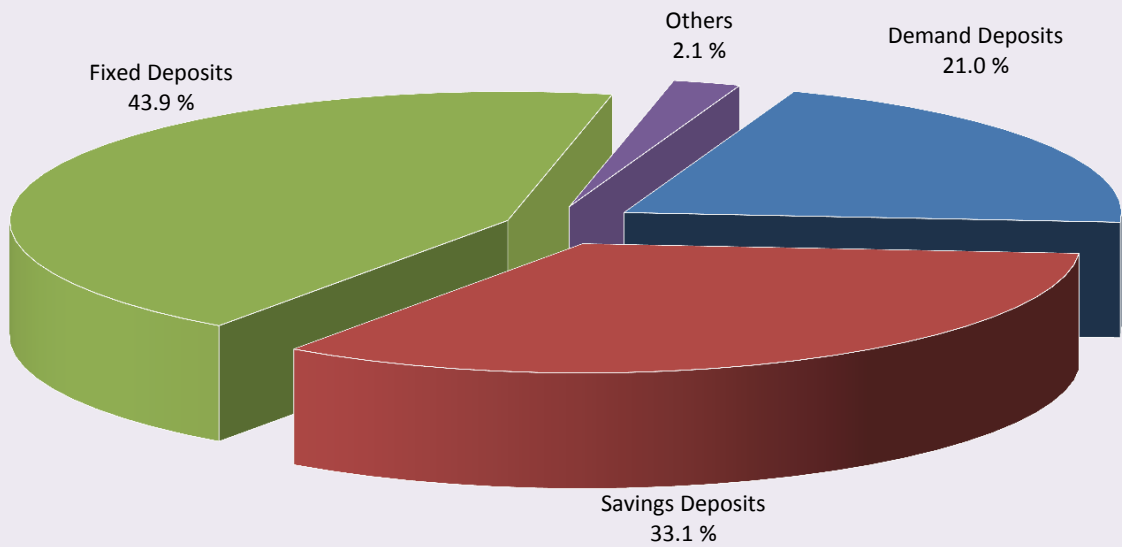


Chart 13: Deposits in Foreign Currency Classified by Type, as of June 2015
