Introduction

Headline consumer price inflation in October 2015 fall to a negative level compared to the preceding month. During this period, Cambodian Riel (KHR) continued to appreciate against US dollar while banking activities through credit to private sector and resident's deposits continued to increase notably. At the same time, the international trade in goods showed a decrease in deficit.

Consumer Price Index

The consumer price inflation in Phnom Penh (month-on-month) decelerated to the negative level - 0.08% in October from 0.32% in September 2015. In which, four out of twelve group indexes decreased while the other eight group indexes increased.



During the same period, the year-on-year percentage change of the CPI for all items increased to 1.28% in October from 0.94% in September 2015, reflected by the increases in prices of food and clothing while oil prices decreased.


Exchange Rate

The exchange rate (market buying rate) was KHR 4,049 per US dollar in October 2015, appreciated by 0.61%, compared to the previous month. This was due to the increase in demand for KHR for tax payment purpose and for spending during national festival days.




Money Supply

Broad money (M2) increased to KHR 47,452 billion in October 2015, up 1% compared to September 2015. The components of M2 including demand deposits and resident's foreign currency deposits increased by 12.1% and 1.6%, respectively, while time and saving deposits and currency outside banks decreased by 8.5% and 1.9%, respectively.



Net Domestic Assets of the Banking Sector


Net domestic assets of the banking sector in October 2015 continued to increase to KHR 21,173.2 billion, up 2.8% from the previous month, this was due to the increase of 1% in domestic credit and 1% in other items net.



The increase in domestic credit was reflected by an increase of 1.4% in credit to private sectors while net claims on government decreased by 3.7%.


Net Foreign Assets of the Banking Sector

Net foreign assets of the banking sector decreased slightly to KHR 26,278.8 billion in October 2015, down by 0.3% from September 2015, mainly due to an increase of 3.9% in total foreign liabilities.




Deposit Money Banks' Operations

Total assets of commercial banks and specialized banks were KHR 78,543.5 billion, up by 1.7% in October 2015 from the previous month.



Interest Rates on Loans and Deposits

In October 2015, the interest rate movement with a maturity of 12-month on deposits and loans showed that the weighted average deposit rate in KHR increased by 0.03% and deposit in US Dollar increased by 0.04%. At the same time, the weighted average lending rate in KHR increased by 0.04% while lending rate in US dollar decreased slightly by 0.01%.




Foreign Tourist Arrivals

In October 2015, the total number of passenger arrivals was 408,922 passengers; up by 30% after decreasing 14.1% last month. The main purpose of the passenger arrivals in Cambodia was for vacation, accounting for more than 88% of the total.




Most of the foreign passengers were from Vietnam, China P.R.C., Lao PDR, Thailand, South Korea, United States of America, Malaysia, Japan, United Kingdom, and Australia.



International Trade in Goods

International trade in goods showed a deficit of KHR 815.4 billion (23.5%) in October, from the deficit of KHR 921.7 billion (25.36%) in September 2015.



The major components of total exports were Garment, Footwear, Rubber, Sawn Timber, and Textile. And the major components of total imports were Petroleum, Vehicles, Motor Bikes, Cigarettes, Steel, Construction Materials, Clothing, Beer, Cement, Cloths, and Gold.







(At Constant 2000 Prices)





Chart 4: GDP by Economic Activity

Chart 5: Investment Fixed Assets by Sectors




Chart 6: Number of Investment Projects by Sectors





Chart 8: Monetary Survey




Chart 9: Components of Money Supply





(Share of Grand Total Deposits)



(Share of Total KHR Deposits)





Chart 13: Deposits in Foreign Currency Classified by Type, as of October 2015
