Introduction

In September 2013, headline consumer price inflation increased moderately, mainly due to the increase in the prices of Food, Recreation and Culture, and Health. Cambodian riel (KHR) exchange rate against US dollar appreciated moderately. Meanwhile, credit to private sector and deposits by residents accelerated. During the same period, the International Trade in goods showed a deficit.

Consumer Price Index

Consumer price inflation in Phnom Penh (month-on-month) accelerated to 0.69% in September 2013 from 0.43% in August 2013 reflecting an increase in consumer price index (CPI), from 153.85 in August 2013 to 154.92 in September 2013.

During the period, eight group indexes increased and other four group indexes decreased. The group indexes showing the increases in the month were: Recreation and Culture (2.22%); Food and Non Alcoholic Beverages (1.20%); Alcoholic Beverages, Tobacco and Narcotics (1.02%); Education (0.83%); Furnishings and Household Maintenance (0.69%); Housing, Water, Electricity, Gas and Other Fuels (0.37%); Health (0.23%) and Restaurants (0.19%).

The group indexes decreasing during the month were: Miscellaneous Goods and Services (1.11%); Transport (0.54%); Communication (0.50%) and Clothing and Footwear (0.02%).

The increased in Food and Non Alcoholic Beverages resulted from the increases of 1.2% in the index for food sub-group and 0.5% in the index for Non-Alcoholic Beverages sub-group. The increase in food sub-group index mainly resulted from the increases in the prices of Fruits (3%), Vegetables (2.1%), Fish and Seafood (1.4%), Pork (0.9%), Chicken (0.7%), Milk, Cheese and Eggs (0.7%), Beef (0.4%), Duck (0.4%), and Rice (0.2%). The increase in Non-Alcoholic Beverages sub-group was due to an increase of 0.7% in the price of Mineral waters, Soft drinks, Fruits and Vegetable juices and 0.2% in the price of Coffee, Tea and Cocoa. The decrease in Transport group index was mainly due to the decreases in the prices of Gasoline (1.6%), Diesel (0.9%), and Motor oil (0.1%).

Based on year-on-year percentage change of the CPI for all items, headline inflation accelerated to 3.7% in September 2013 from 3.3% in August 2013, mainly due to the increases in the prices of food, recreation and culture, and health.

Exchange Rate

The value of KHR against the US dollar appreciated moderately in September 2013. The market buying rate decreased from KHR 4,092 per US dollar at the end of August 2013 to KHR 4,067 per US dollar at the end of September 2013, an appreciation of 0.61% compared to the appreciation of 0.04% in August 2013.

During the period, daily market buying rate varied between KHR 4,067 and KHR 4,092 per US dollar. As shown in Chart 7, the value of KHR was fixed with a rate of KHR 4,092 per US dollar for the first seven days of the month. After that, the KHR appreciated to treat on a rate of KHR 4,081 per US dollar from the eighth to the twenty seventh of the month. Later

on, the KHR appreciated consecutively from KHR 4,071 per US dollar on the twenty eighth to KHR 4,067 per US dollar at the end of the month. This was mainly due to the increase in the demand for KHR for private's purchasing in preparation for the Pchum Ben day and tax payment purpose.

Money Supply

In September 2013, broad money (M2) increased moderately after decreasing in the previous three months consecutively, up by KHR 216.7 billion (0.7%) after decreasing KHR 1,177.3 billion (3.9%) in August 2013, from KHR 29,138.9 billion in August 2013 to KHR 29,355.5 billion in September 2013. The increase resulted from the increases of KHR 110.3 billion (0.5%) in residents' foreign currency deposits, KHR 88.2 billion (2.1%) in currency outside banks, and KHR 81 billion (9.8%) in time and saving deposits while demand deposits decreased by KHR 62.9 billion (13.5%).

Net Domestic Assets of the Banking Sector

Net domestic assets of the banking sector increased significantly in September 2013 after decreasing in the previous month, up by KHR 325.4 billion (3.2%) after decreasing KHR 32 billion (0.3%) in August 2013. This was due to an increase of KHR 569.9 billion (2.5%) in domestic credit while other items net decreased by KHR 244.5 billion (1.9%). The increase in domestic credit was reflected by an increases of KHR 499.1 billion (1.9%) in credit to private sector and KHR 73.6 billion (2.6%) in net claims on government while credit to state enterprises decreased by KHR 2.9 billion (24.7%). The increase in net claims on government was entirely due to a decrease of KHR 73.7 billion (2.3%) in government deposits while claims on government remained unchanged.

The decrease in other items net was mirrored by a decrease of KHR 111.7 billion (61.8%) in other items contributed with the increases of KHR 108.9 billion (0.9%) in capital and reserves and KHR 23.9 billion (3.1%) in restricted deposits.

Net Foreign Assets of the Banking Sector

Net foreign assets of the banking sector continued to decrease in the four months consecutively, down by KHR 108.7 billion (0.6%) in September 2013 after decreasing KHR 1,145.2 billion (5.7%) in August 2013. This was due to an increase of KHR 661.6 billion (10.4%) in total foreign liabilities while in total foreign assets increase only by KHR 552.8 billion (2.2%). The increase in total foreign liabilities resulted from an increase of KHR 656.3 billion (11.1%) in foreign liabilities of commercial banks and KHR 5.2 billion (1.2%) in foreign liabilities of the National Bank of Cambodia. The increase in total foreign assets resulted from an increase of KHR 638.1 billion (8.2%) in foreign assets of commercial banks while foreign assets of the National Bank of Cambodia declined by KHR 85.3 billion (0.5%).

Deposit Money Banks' Operations

As shown in Table 12, total assets of commercial banks and specialized banks increased significantly from KHR 45,984.8 billion in August 2013 to KHR 47,076.8 billion in September 2013, up by KHR 1,092 billion (2.4%) compared to the decrease of KHR 889.2 billion (1.9%) in August 2013. This increase was due to the increases of KHR 638.1 billion (8.2%) in foreign assets, KHR 496.2 billion (1.9%) in loans and advances to residents, and KHR 13.9 billion (0.3%) in fixed and other domestic assets while cash and deposits with the central bank decreased by KHR 56.2 billion (0.7%). The increase in loans and advances to residents was due to an increase of KHR 499.1 billion (1.9%) in credit to private sector while credit to nonfinancial public enterprises declined by KHR 2.9 billion (24.7%).

The total liabilities of all banks in the month showed increasing which was reflected by the increases of KHR 656.3 billion (11.1%) in foreign liabilities, KHR 197.3 billion (3.4%) in domestic liabilities, KHR 131.6 billion (0.5%) in deposits by residents and KHR 106.7 billion (1.1%) in capital and reserves. The increase in deposits by residents resulted from the increases of KHR 110.3 billion (0.5%) in foreign currency deposits and KHR 81 billion (9.8%) in time and saving deposits while demand deposits decreased by KHR 59.7 billion (16.7%).

Interest Rates on Loans and Deposits

In September 2013, the interest rate movement with a maturity of 12-month on loans and deposits showed that the weighted average deposit rate in KHR decreased by 0.03% from 5.94% in August 2013 to 5.91% in September 2013 while the same rate of deposit in US Dollar decreased by 0.01% from 4.39% in August 2013 to 4.38% in September 2013.

During the period, the weighted average lending rate in KHR was fixed with a rate of 11.93% in September 2013 while the same rate for lending in US dollar decreased by 0.07% from 11.37% in August 2013 to 11.30% in September 2013.

The banks' interest rate spread between loan and deposit rates in KHR widened from 5.99% in August 2013 to 6.02% in September 2013, and the spread in US dollar narrowed from 6.98% in August 2013 to 6.92% in September 2013.

Foreign Tourist Arrivals

The number of foreign passenger arrivals in Cambodia decreased moderately in September 2013 after increasing in the previous month. The total number of passenger arrivals decreased from 342,064 persons in August 2013 to 283,787 persons in September 2013, down by 58,277 persons (17%) following the increase of 3,303 persons (1%) in a month earlier. The decrease in the number of passenger arrivals was apportioned by modes of arrival as follows: Passenger arrivals by land, down by 34,106 persons (18.6%); Passenger arrivals by air at Siem Reap International Airport, down by 16,600 persons (19.1%); and Passenger arrivals by air at Phnom Penh International Airport, down by 7,847 persons (11.7%) while Passenger

arrivals by water, up by 276 persons (5.7%). The main purpose of the passenger arrivals in Cambodia was for vacation accounting for 94% of the total. Most of the foreign passengers were from Vietnam (21%), Lao PDR (13.8%), China P.R.C. (12.1%) and South Korea (7.6%) followed by Japan (6.6%), Thailand (5.8%), Australia (4%), Malaysia (3.8%), Philippine (3.3%), and the United States of America (3.2%).

International Trade in Goods

In September 2013, the international trade in goods showed a deficit of KHR 347.2 billion (14.3%) after showing the surplus for the first time of the year, by KHR 30.6 billion (1.1%) in August 2013.

Total exports (fob) decreased modestly by KHR 667.3 billion (24.3%) in September 2013 after increasing KHR 519.3 billion (23.3%) in August 2013, from KHR 2,748.2 billion in August 2013 to KHR 2,080.9 billion in September 2013. The decrease was mainly due to the decreases in the exports of Garment KHR 598 billion (25.6%), Footwear KHR 25.3 billion (21.7%), Rubber KHR 18.1 billion (23.9%), and Textile KHR 0.1 billion (1.3%) while exports of Swan Timber increased by KHR 7.5 billion (46.7%).

Total imports (fob) declined moderately in September 2013, down by KHR 289.5 billion (10.7%) after increasing KHR 150.9 billion (5.9%) in August 2013, mainly due to the decreases in imports of Petroleum products KHR 45.1 billion (14%), Cigarettes KHR 33.6 billion (41.7%), Cloths KHR 12.2 billion (32.6%), Cement KHR 8.4 billion (35.4%), Motor Bikes KHR 8.4 billion (24.9%), Construction Material KHR 6.3 billion (26.2%), Steel KHR 3.6 billion (19.1%), and Sugar KHR 1.9 billion (32.7%) while imports of Vehicles increased by KHR 19.1 billion (16.3%). In the meantime, imports of other commodities changed slightly.





(At Constant 2000 Prices)





Chart 4: GDP by Economic Activity




Chart 7: Trend of Daily Exchange Rate in September 2013



Chart 9: Monetary Survey




Chart 10: Components of Money Supply





(Share of Grand Total Deposits)



(Share of Total KHR Deposits)





Chart 14: Deposits in Foreign Currency Classified by Type, as of September 2013


