## Introduction

Overall consumer price inflation in August 2015 decelerated moderately compared to the preceding month. During this period, Cambodian Riel (KHR) appreciated against US dollar while banking transaction reflected by credit to private sector and deposit continued to increase notably. At the same time, the international trade in goods showed an increase in deficit.

## Consumer Price Index

The consumer price inflation in Phnom Penh (month-on-month) eased to 0.29% in August from 0.54% in July 2015. In which, two out of twelve group indexes decreased while nine group indexes increased and the other one remained stable.



During the same period, the year-on-year percentage change of the CPI for all items remained stable with the same rate of 0.80% as of July 2015, reflected by the increases in prices of food and clothing while oil prices showing the decrease markedly.


## Exchange Rate

The exchange rate (market buying rate) was KHR 4,098 per US dollar in August 2015, appreciated by 0.36%, compared to the previous month. This was due to an increase in demand for KHR for tax payment purpose.



## Money Supply

Broad money (M2) increased moderately to KHR 46,701.3 billion in August 2015, up 1.5% compared to July 2015. The components of M2 including time and saving deposits and resident's foreign currency deposits increased by 19.8% and 1.3%, respectively, while demand deposits decreased by 9.2%.



## Net Domestic Assets of the Banking Sector


Net domestic assets of the banking sector in August 2015 continued to increase to KHR 20,401.9 billion, up 5.3% from the previous month, this was due to the increases of 2.4% in other items net and 1.7% in domestic credit.



The increase in domestic credit was reflected by the increases of 1.3% in credit to private sectors and 0.7% in net claims on government.


## Net Foreign Assets of the Banking Sector

Net foreign assets of the banking sector continued to decrease to KHR 26,299.4 billion in August 2015, down by 1.3% from July 2015, mainly due to an increase of 2.7% in total foreign liabilities.




### Deposit Money Banks' Operations

Total assets of commercial banks and specialized banks were KHR 76,470.8 billion, up by 1.8% in August 2015 from the previous month.



### Interest Rates on Loans and Deposits

In August 2015, the interest rate movement with a maturity of 12-month on loans and deposits showed that the weighted average deposit rate in KHR was 6.65%, down by 0.11% while deposit in US Dollar was 4.40%, up by 0.02%. At the same time, the weighted average lending rate in KHR was 16.20%, down by 0.03% while lending rate in US dollar was 11.59%, up by 0.05%.




### Foreign Tourist Arrivals

In August 2015, the total number of passenger arrivals was 366,096 passengers; up by 0.5% following the increase of 14.5% last month. The main purpose of the passenger arrivals in Cambodia was for vacation, accounting for more than 88% of the total.



Most of the foreign passengers were from Vietnam, China P.R.C., South Korea, Lao PDR, Thailand, Japan, France, United States of America, Malaysia, and United Kingdom.




## International Trade in Goods

International trade in goods showed a deficit of KHR 824 billion (21.2%) in August, from the deficit of KHR 430 billion (10.7%) in July 2015.



The major components of total exports were Garment, Footwear, Rubber, and Textile. And the major components of total imports were Petroleum, Vehicles, Gold, Cigarettes, Steel, Motor Bikes, Construction Materials, Cement, Clothing, Beer, and Cloths.





(At Constant 2000 Prices)





Chart 4: **GDP by Economic Activity**










**Chart 11: Deposits with Deposit Money Banks Classified by Currency, as of August 2015**  
(Share of Grand Total Deposits)




