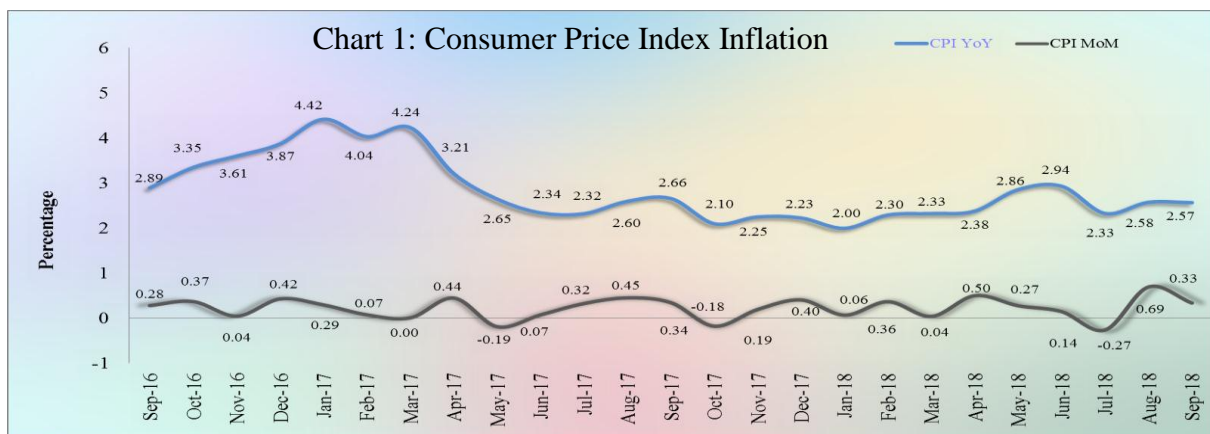

Introduction

Headline consumer price inflation in September 2018 decelerated compared to a month earlier. Whereas, Cambodian Riel (KHR) depreciated against US dollar. During this period, resident's foreign currency deposits and credit to private sector of the banking system continued to increase. At the same time, the international trade in goods showed an increase in deficit.

Consumer Price Index

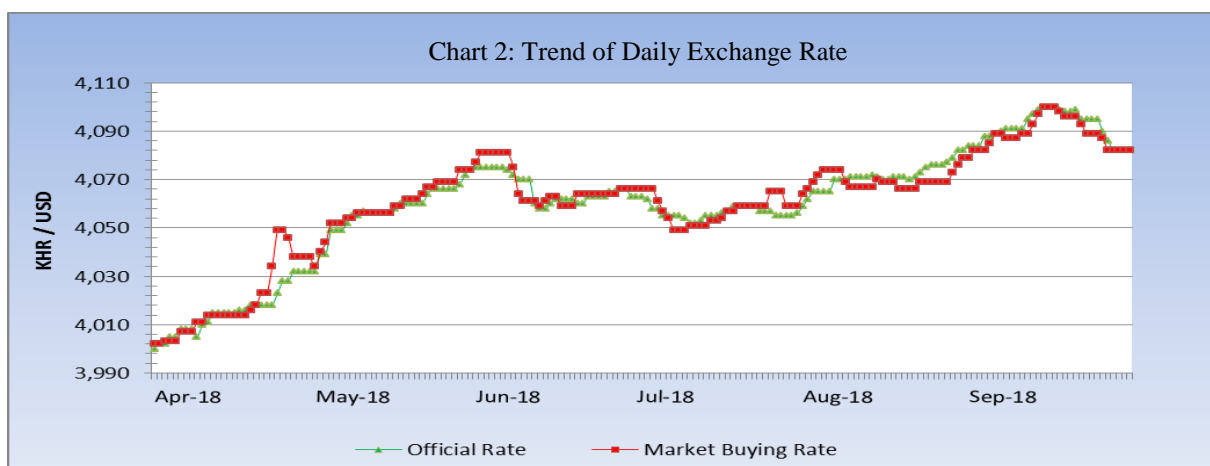
The consumer price inflation in Phnom Penh (month-on-month) eased to 0.33% in September 2018 from 0.69% in August. In which, six out of twelve group indexes decreased while other six group indexes increased.



During the same period, the year-on-year percentage change of the CPI for all items decreased slightly to 2.57% from 2.58% in August, reflecting the lower hike in food prices.

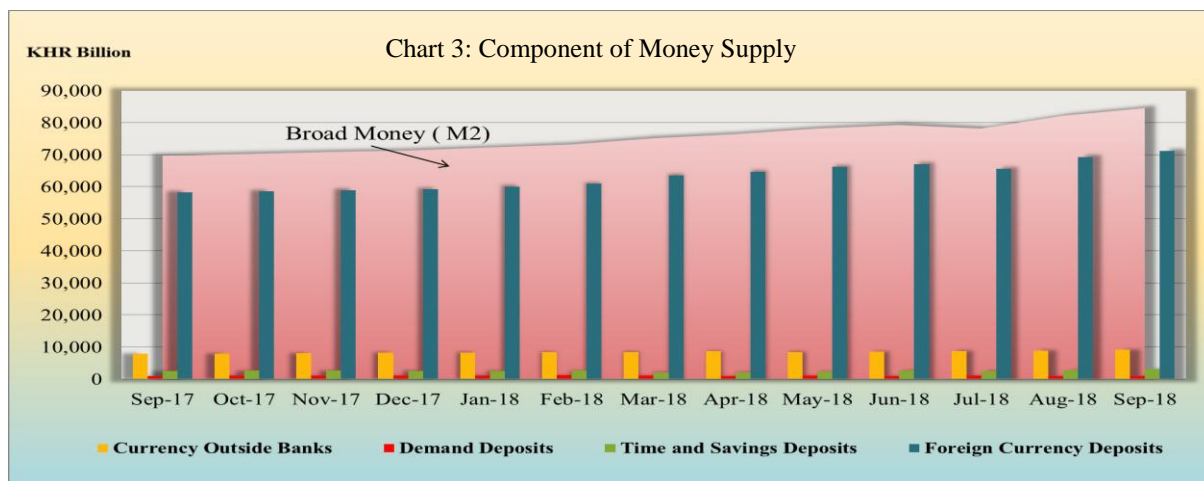
Exchange Rate

The end-period exchange rate (market buying rate) was KHR 4,082 per US dollar in September 2018, depreciated by 0.07% compared to the previous month. This was mainly due to decreases in demand for KHR for tax payments along with the appreciation of US dollar in the world market.



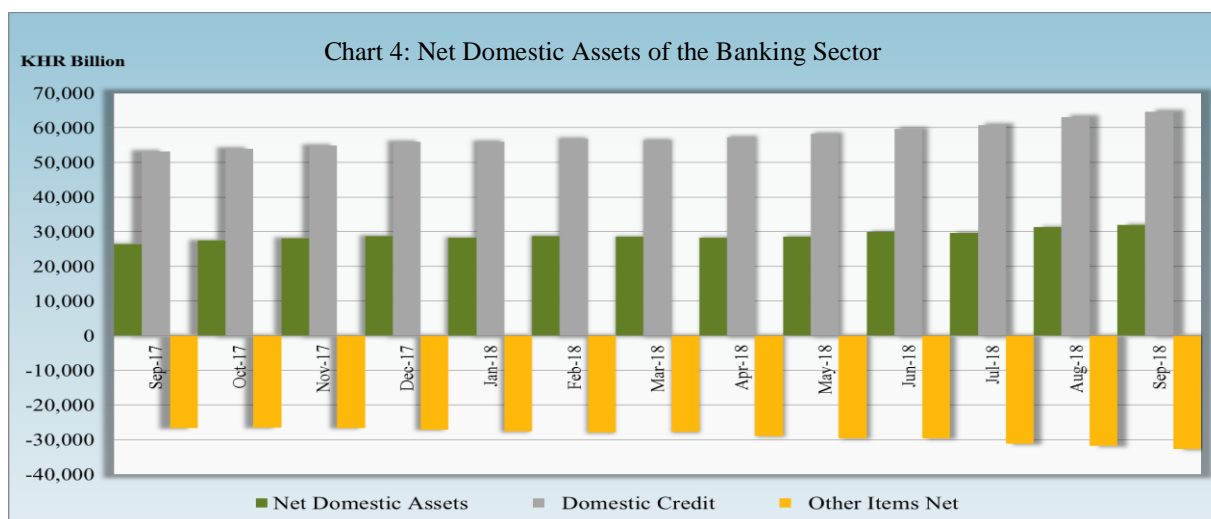
Money Supply

Broad money (M2) continued to increase to KHR 84,611.3 billion in September 2018, up by 3.1% compared to August. The components of M2 including time and saving deposits, resident's foreign currency deposits, and currency outside banks increased by 14.8%, 2.7%, and 2.7%, respectively. While demand deposits decreased by 5.2%.



Net Domestic Assets of the Banking Sector

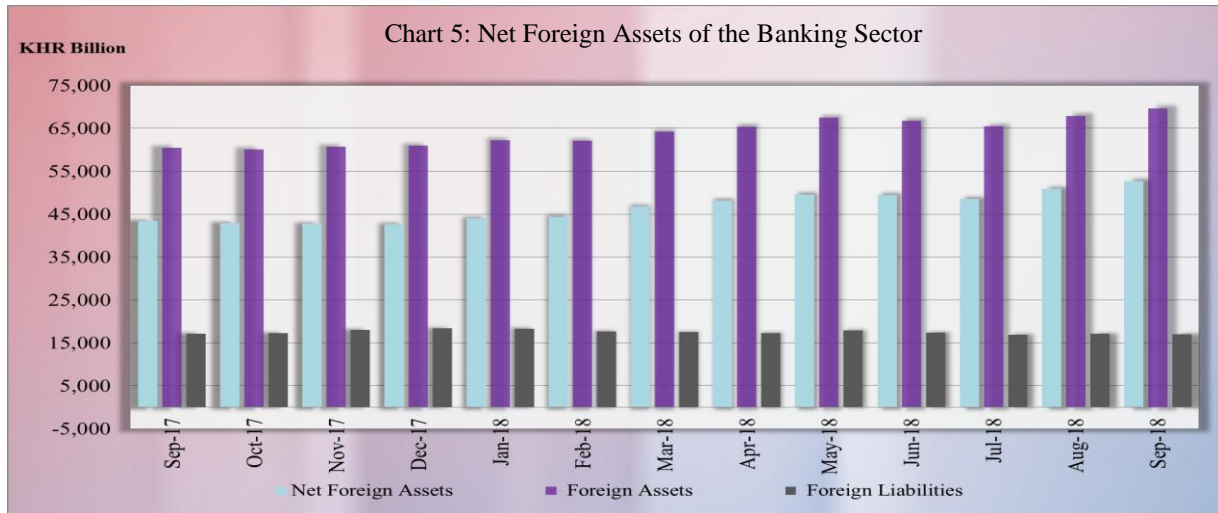
Net domestic assets of the banking sector increased to KHR 31,941.8 billion in September 2018, up by 2.1% compared to the previous month. This was due to an increase of 2.9% in domestic credit while other items net decreased by 3.7%.



The increase in domestic credit was reflected by the increases of 2.7% in credit to private sector where as net claims on government declined by 1.7%. The decrease in net claim on government was entirely due to an increase in government deposits. The decline in other items net was due to the decrease of 9.3% in other contributed with the increases of 3.1% in capital and reserves while restricted deposits declined by 0.1%.

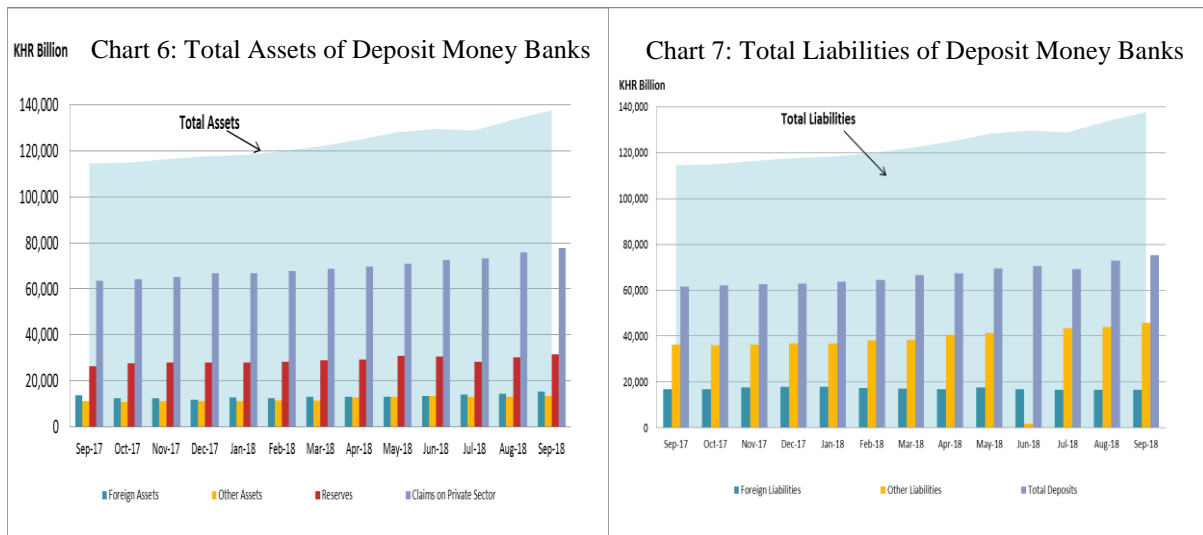
Net Foreign Assets of the Banking Sector

Net foreign assets of the banking sector increased to KHR 52,669.4 billion by the end of September 2018, up by 3.6% from August. This was due to the increase 2.5% in total foreign assets contributed with the decrease of 0.6% in total foreign liabilities.



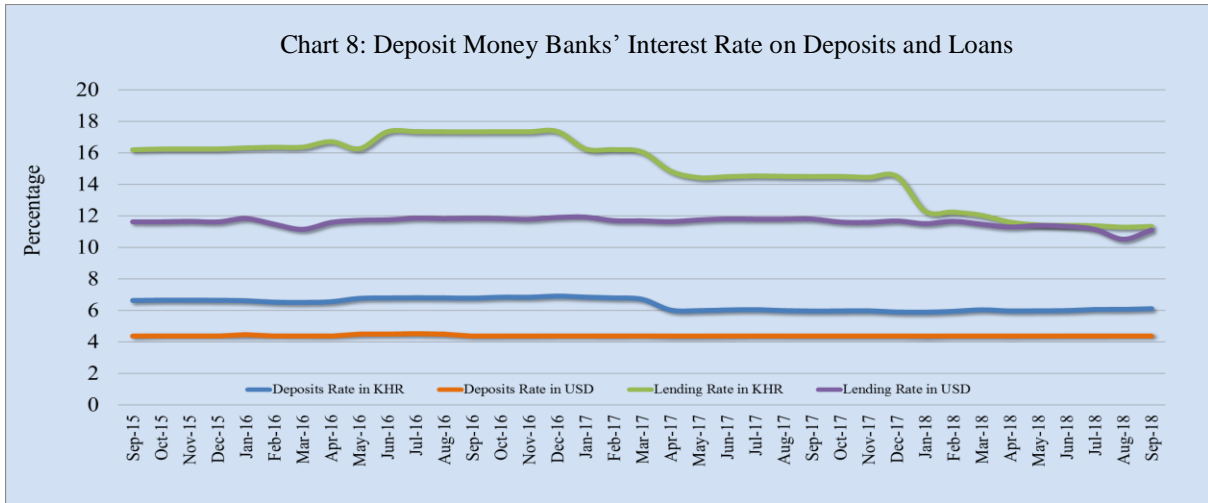
Deposit Money Banks' Operations

Total assets of commercial banks and specialized banks were KHR 137,750.2 billion, up by 3% in September 2018 compared to the previous month.



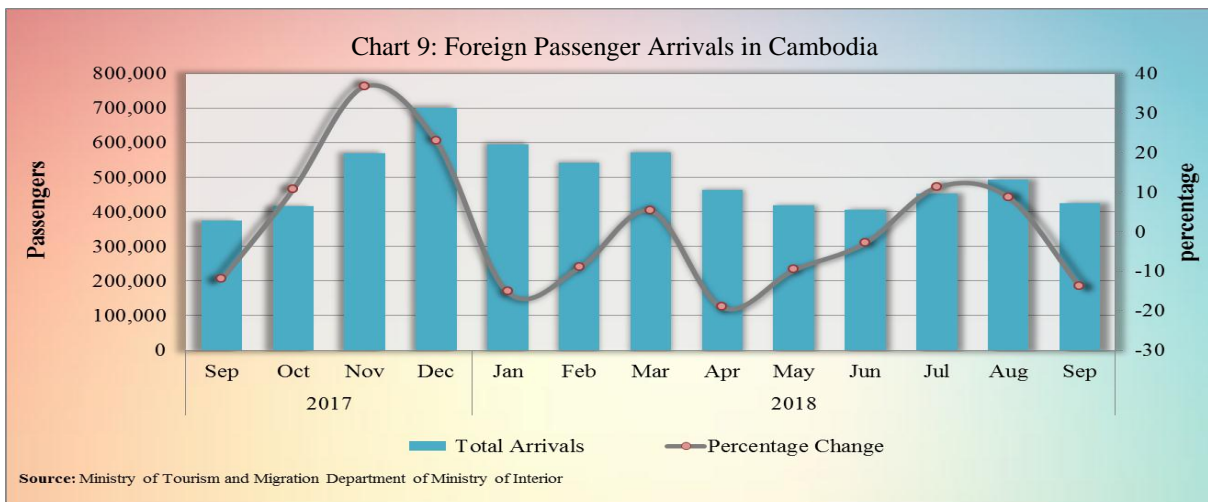
Interest Rates on Deposits and Loans

In September 2018, the interest rate movement with a maturity of 12-month on deposits and loans showed that the weighted average deposit rate in KHR increased by 0.05% to 6.11% while deposit rate in US dollar decreased by 0.01% to 4.44%. At the same time, the weighted average lending rate in KHR and US dollar increased by 0.05% and 0.6%, respectively.



Foreign Tourist Arrivals

In September 2018, the total number of passenger arrivals was 426,274 passengers, decreased by 13.7% after the increase of 8.8% in the preceding month. The main purpose of the passenger arrivals in Cambodia was for vacation, accounting for more than 82% of the total.



Most of the foreign passengers were from China P.R.C., Vietnam, Lao PDR, Thailand, Malaysia, Japan, United States of America, South Korea, Australia, and Taiwan.



International Trade in Goods

International trade in goods showed a deficit of KHR 739.5 billion (12.9%) in September 2018, following the deficit of KHR 563.3 billion (9.1%) in August.



The major components of total exports were Garment, Footwear, Rice, Bicycle, Rubber, Electrical Part, Wood Products, and Vehicle part. And the major components of total imports were Fabric, Vehicles, Oil, Food and Beverage, Construction Equipment, Garment, Gold, Cigarettes, Steel, Fertilizer, and Medicine.

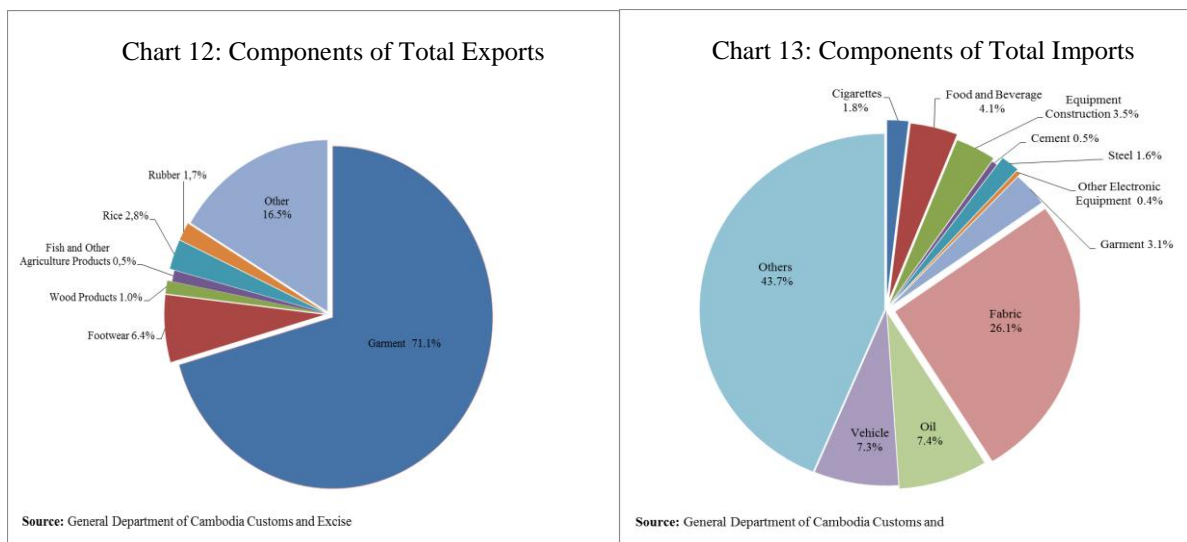

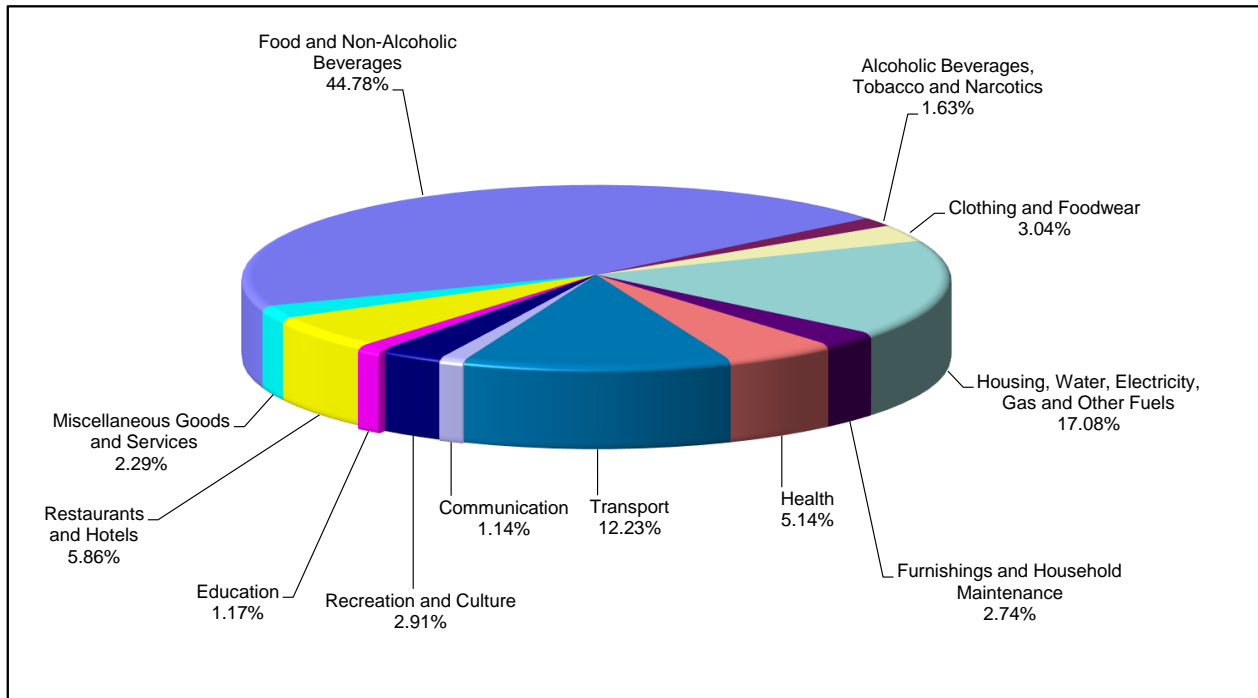

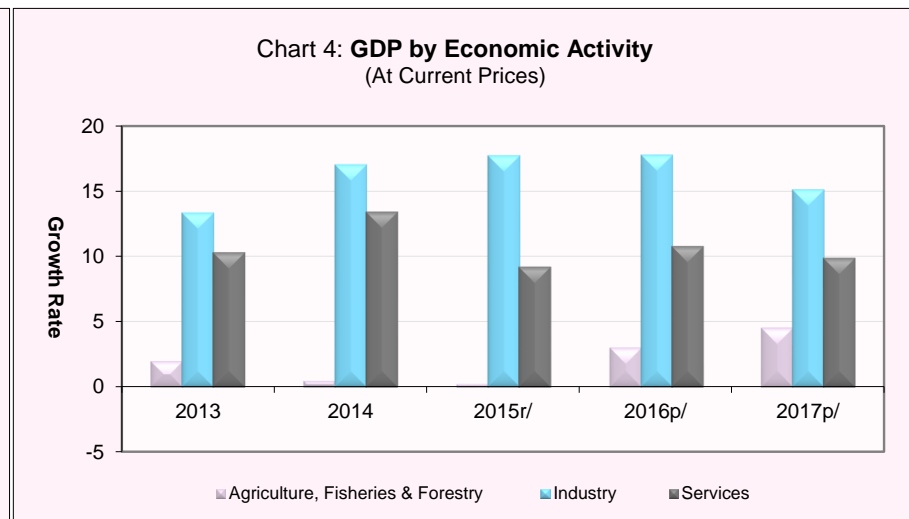
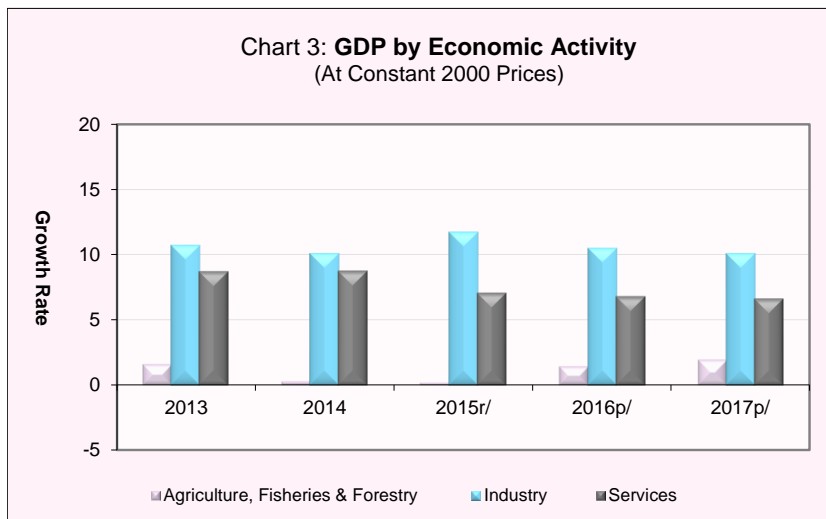
Chart 2: Weight of All Group Indices in Consumer Basket

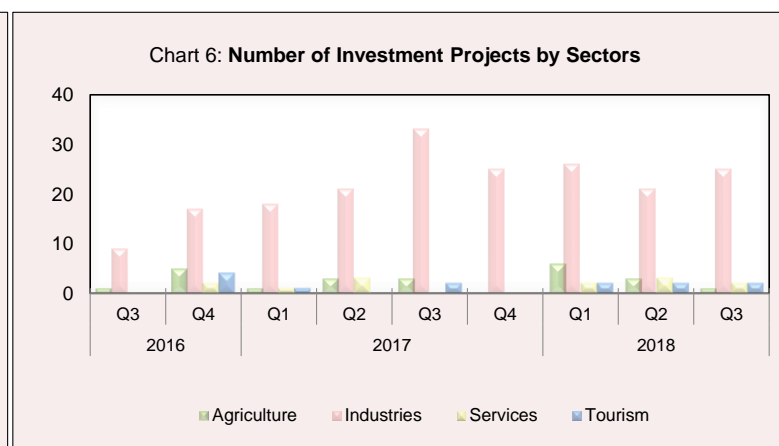
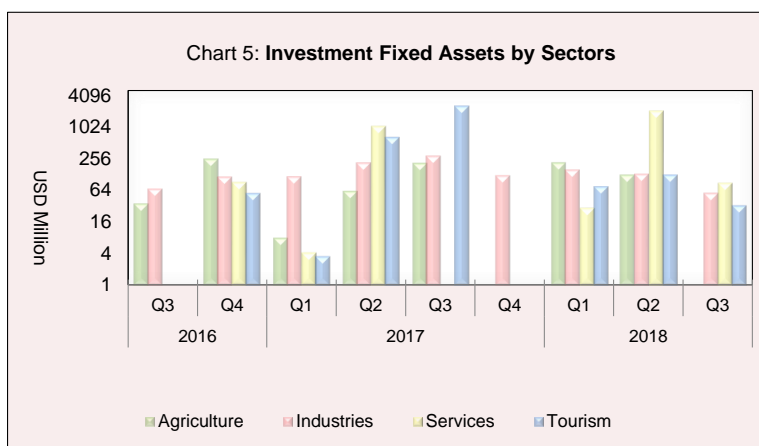

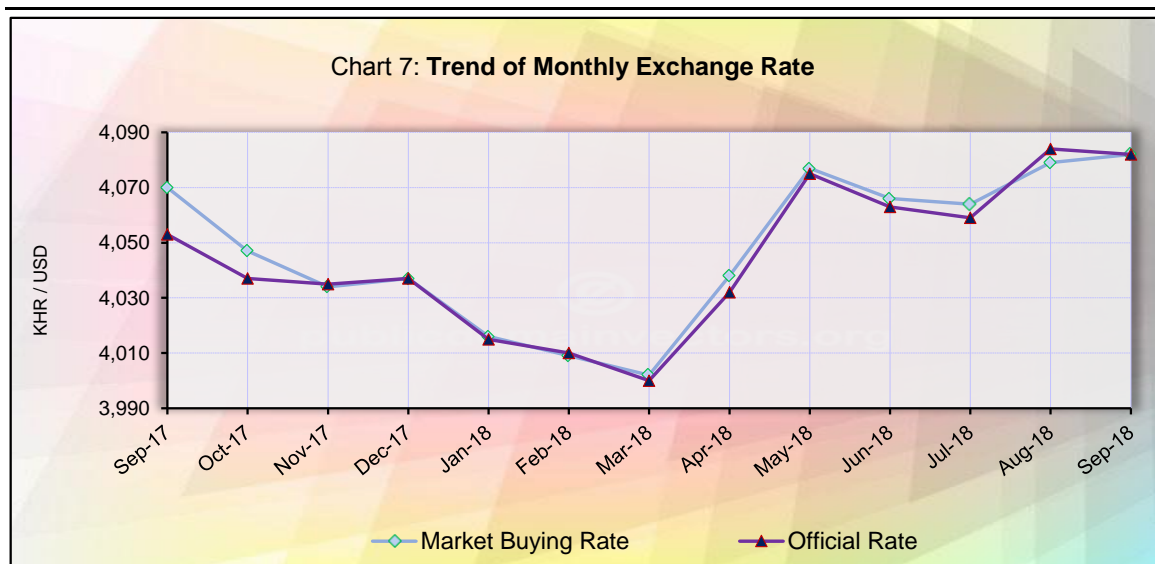

Chart 8: Monetary Survey

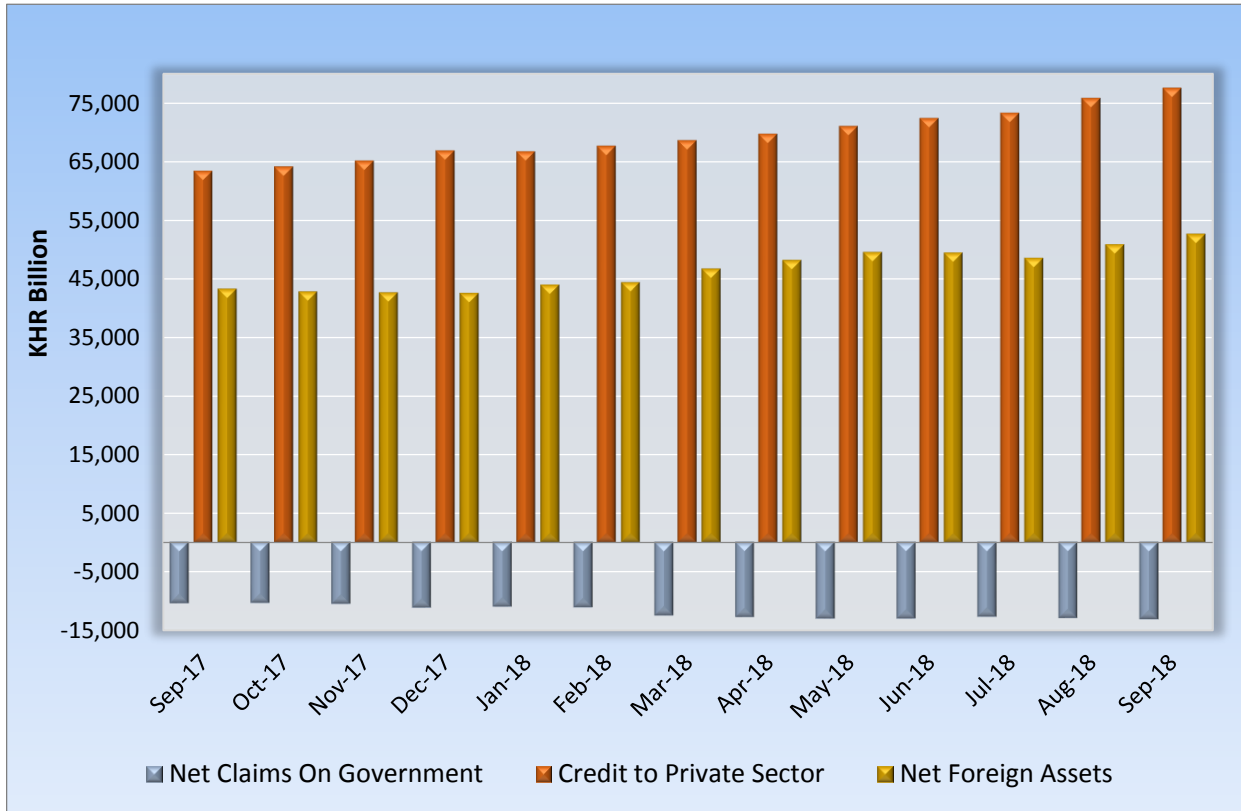


Chart 9: Components of Money Supply

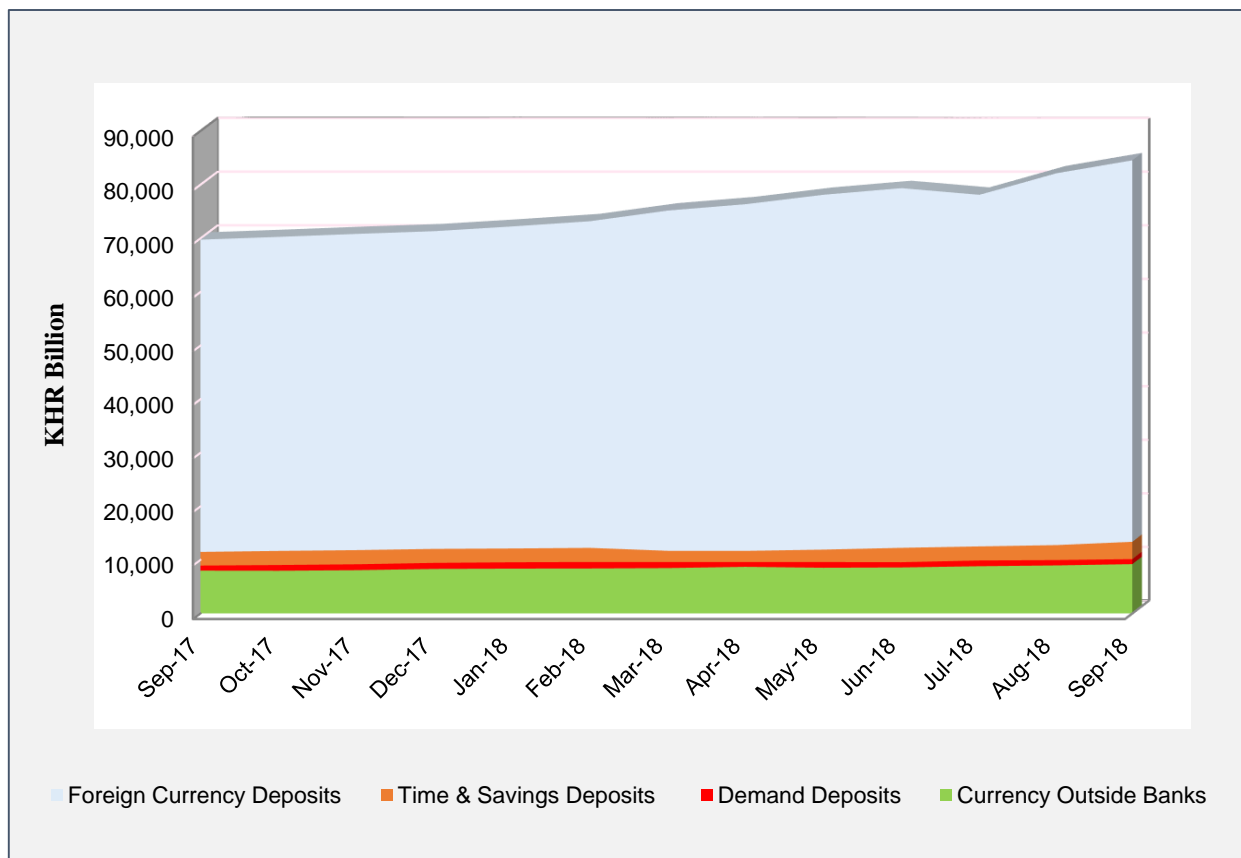

(Share of Total Credits)

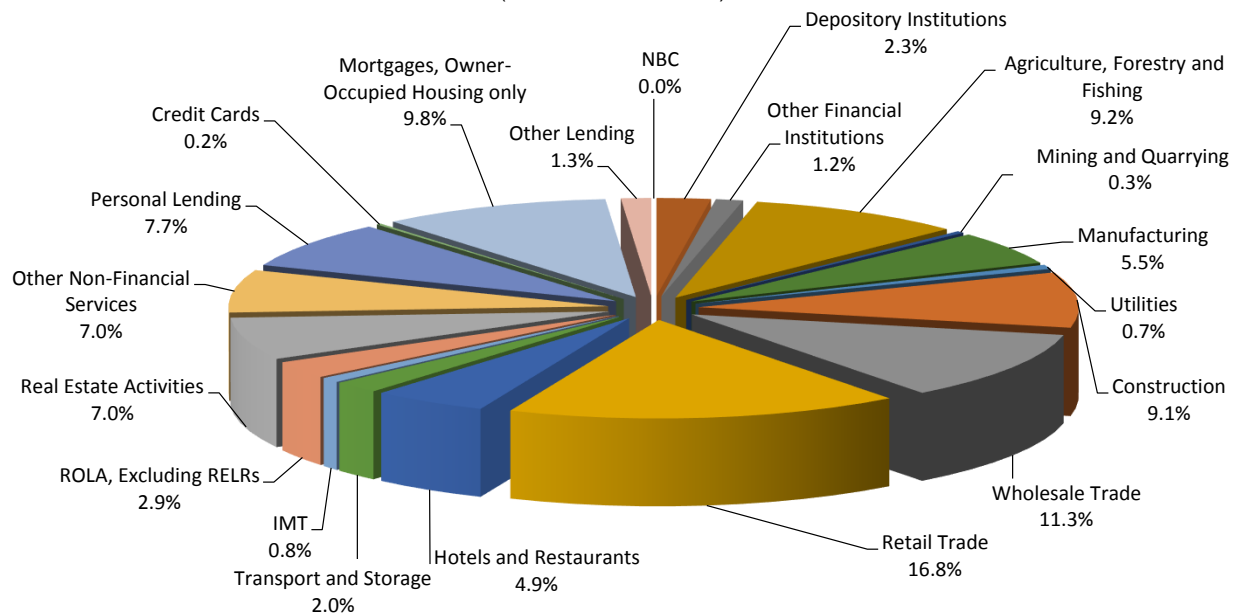

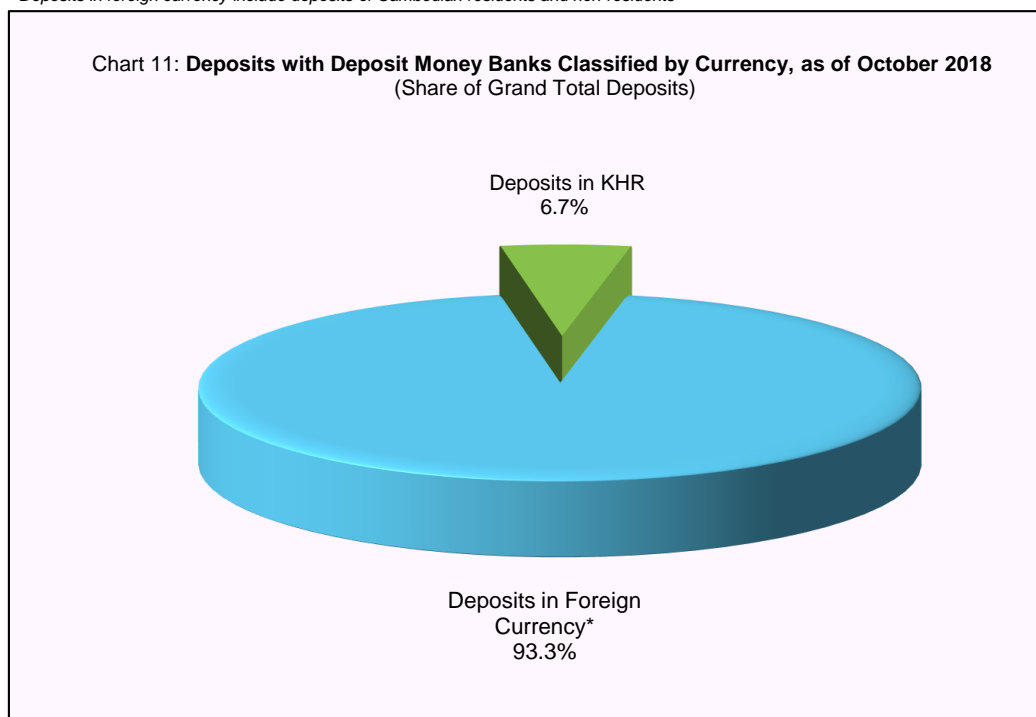

(Share of Total KHR Deposits)

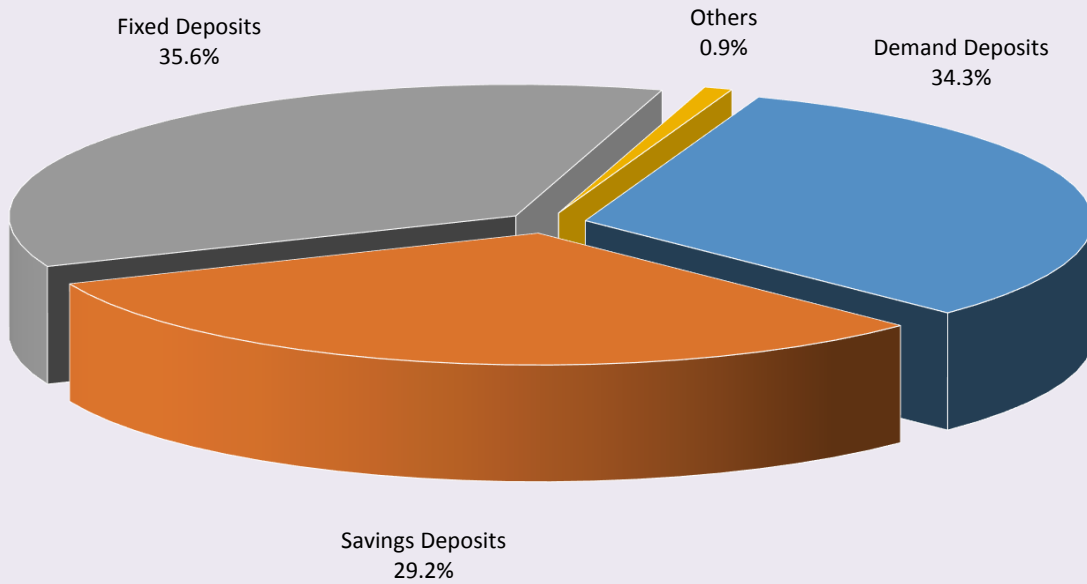
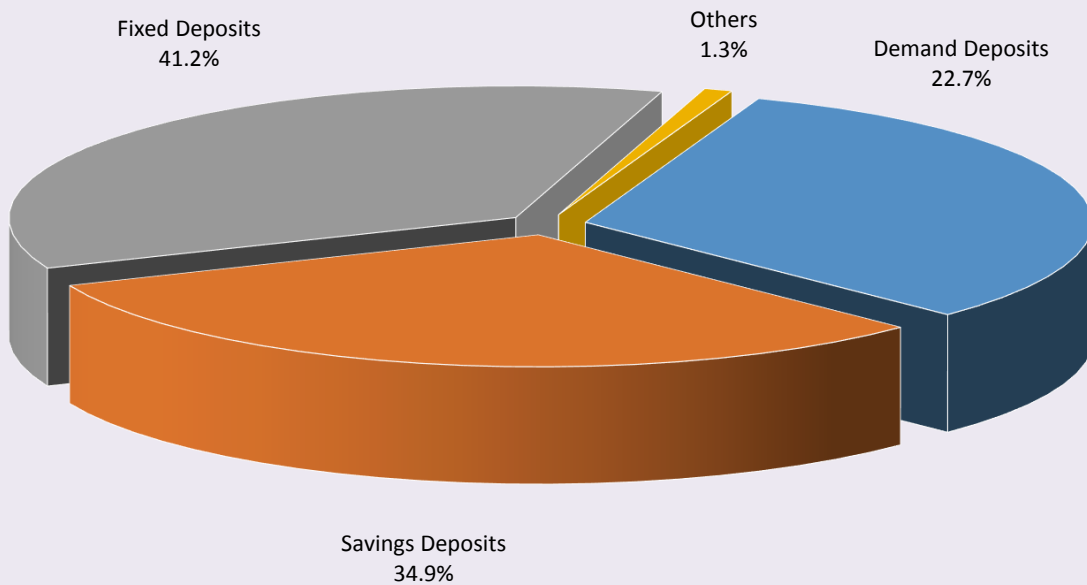


Chart 13: Deposits in Foreign Currency Classified by Type, as of September 2018

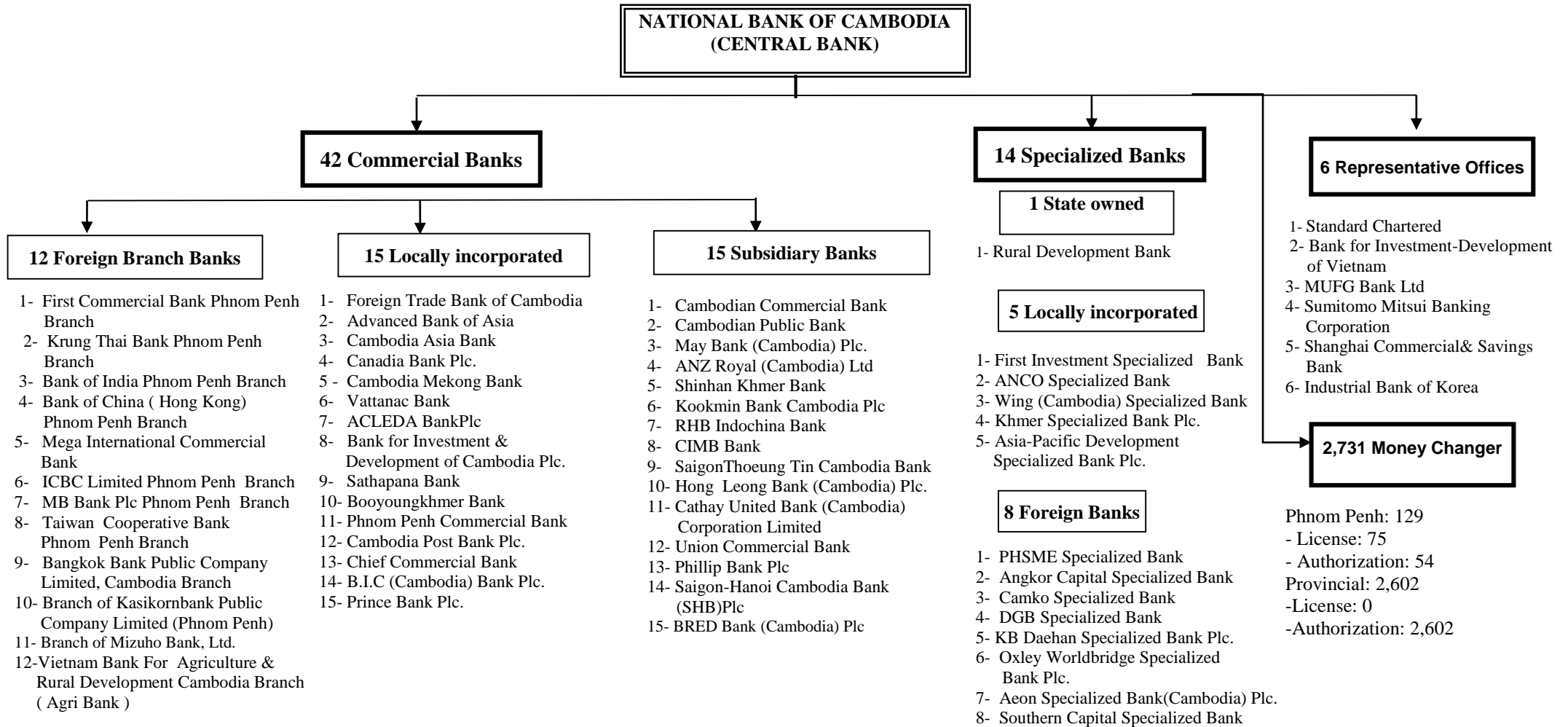
