June 2009 (Percent of Total Credit)**

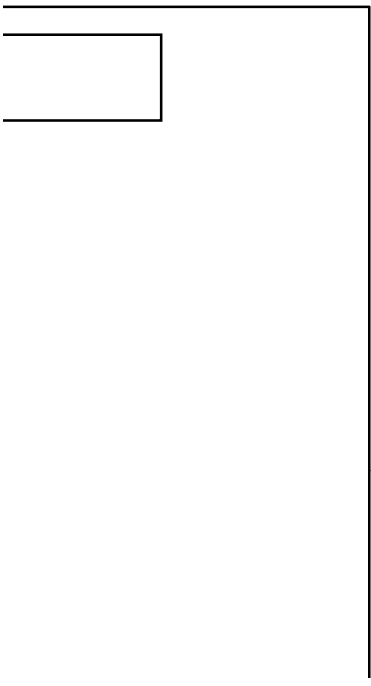
